9. Reports

9.1. Elected Official and City Department Reports –

Freddy Cupen-Ames (Department of Neighborhood Empowerment) : Introduced himself as MVCC's new DONE representative. Has been with DONE for 1 year. Prior experience as Housing Navigator II for LA Family Housing. Also worked in Rent Stabilization outreach in Beverly Hills. Was a Board member of North Hollywood West Neighborhood Council (2014) and Budget Advocates and Planning Committee for Congress of Neighborhoods. Stated that he is here to guide and assist and will be emailing regularly with important dates/information. Reminded all Board member to remain current on required training. DONE website is being re-designed. Informational meeting regarding this on Aug 31, 2020 from 6:30-7:30 PM.

Julien Antelin (DONE Director of Innovation): announced he is replacing Seme Park. Mentioned budget cutbacks at DONE. Neighborhood Advocates reduced from 17 to 12. Acknowledged appointment of Wheeler as Data Liaison and mentioned that his dept is committed to providing resources to facilitate community engagement in the City's decision-making process.

- Second Vice-Chair – Christine Stemar-*missing St Andrew's key has been located and will be returned shortly*
- Secretary – Mary Hruska-*submitted written report*
- Treasurer – Holly Tilson-*every Neighborhood Council (NC) has been allocated 32K this year. This is down from last year's allocation (40K). MVCC is allowed to encumber 3.1K of which 2.5 K is for The Web Corner and \$600 is for Bus Bench ads. City requests that MVCC have Motions once again for these to acknowledge that these encumbered funds are being spent despite the fact that we have already done 2 motions for them. This is still a learning process for all. Every NC was allowed to carry over 10K. We have carried over \$5,9040. Will be added to our budget next Ex Fin. One outstanding expenditure, a board reimbursement. Check issued but not yet cashed. No need for budget adjustments at this time. Need to re-approve Web Corner and Bus Bench allocations. Approved \$120 for Business Card redesign can come out of Operations. Also an approved \$500 for Business Cards, which can come out of Operations as well. Approved \$150 for Neighborhood Association Newsletter ads can come out of Outreach*

9.3. Zone Director Reports

- Zone 1 – Stacy Shure-*Westside Village Homeowners Association hosted a successful ZOOM meeting to discuss the Dept of City Planning (DCP)'s Draft Palms-Mar Vista-Del Rey Community Plan. Hope to have some motions for Community Plan/Special PLUM at the end of the month*
- Zone 2 – Martin Rubin-*North Westdale Resident's Association just put out it's 12th issue (40th Volume) newsletter. It has the Community Plan Update on the front page. Gratified to hear DCP has given the community a 2-week extension. Are issues with homeless encampments in Zone 2. There is a very disturbing one on the Gateway median near the 10 FWY. Noticed that "pedestrians Prohibited" signs had been posted there and seemed to be somewhat effective. Can submit information regarding these for inclusion in the Homeless Committee's report.*
- Zone 3 – Mary Hruska-*see written report*
- Zone 4 – Rob Watkins, M.D.-*referred to written report. Added that he has received numerous communications from the community referencing that its concerns regarding the encampment under the 405 are not being addressed. Also mentioned that the encampment on the median on Venice Blvd at Wasatch was successfully addressed by Tyler Proctor, who worked with Nick Sundback (CD11) and SLO Villery. Thanked Tyler, Mr Sundback and Officer Villery.*
- Zone 5 – Michelle Krupkin *reported a shooting at 12 noon [today] on Inglewood Blvd in Zone 5. between Venice and Washington Blvds. Someone was taken into custody with regard to it. There are numerous homeless encampments in Zone 5, mostly along Grand View and Venice Blvds. Varies from 5-8. Will be submitting a report on this monthly to be incorporated into Homeless Committee report. Is working with South Mar Vista Neighborhood Association to provide input to DCP on the Draft Community Plan. Mentioned concerns regarding Venice Placemaking project hosting in-person meetings*

- at the Mar Vista Farmer’s Market during the pandemic.
- Zone 6 – Holly Tilson-big news is Tyler Proctor’s success in getting part of the Venice Blvd median at Wasatch cleaned up. Additionally, Zone 6 and 7 folks will be working together on a letter writing campaign/petitions to DCP regarding the Community Plan update
- Zone 7 – VACANT

Arts/Education & Culture: Hill reported that the Mar Vista Menagerie at Mar Vista Park will be postponed due to the city not issuing permits for these types of events at this time.

Public Health & Safety (PH&S): Stemar reported that there are still some Neighborhood Watch signs as well as “Drive Like” signs available for anyone who would like one

Transportation & Infrastructure (T&I) : Krupkin stated that there are 4 T&I motions on the agenda that were deferred from last month and urged the board to address them.

Additionally, reported that T&I and PH&S will be switching meeting days beginning

In September: T&I will be the first Thursday and PH&S the first Wednesday of the month

Board Comment:

Shure: requested that DCP present the full picture in the upzoned areas, which is not Presented in the Draft

Hruska: committee calculated Dwelling Unit Capacity for Mar Vista and it shows existing zoning can accommodate anticipated population up to 2030 with excess capacity. The motion also makes recommendations as to how affordable housing can be achieved, such as Targeted Affordable housing and utilizing Tiny Homes. A second motion on the agenda addresses a clause in the Transit Oriented

Rubin: questioned environmental issues associated with proposed upzoning.

Added that he strongly favors down-zoning

Ambriz: spoke in opposition to the motion, and requested additional data

Inouye: stated that the motion should be postponed until more solutions for Affordable housing are presented

Curry: expressed doubts that increasing density without consideration of Infrastructure, gentrification and the environment

Wheeler: this motion is based on a lot of stakeholder feedback. It represents stakeholders at work

Tilson: mentioned that the motion is time-sensitive and needs to be voted on now. Motions to address other issues can still be written

Ashely Zeldin: Spoke in support of motion. Cited City of LA's professed 2017 goal of reducing urban temperatures by 7% via spending 5M to plant 40,000 trees

Kalani Whittington: Spoke in support of motion. Los Angeles is a desert. Not meant to sustain 10 million people

Tyler Le Ferriere: Supports motion but cautioned that it could be used as a tool to hinder development

Helen Fallon: spoke in support of motion. Decks are not a substitute for trees

Adrianna De La Cruz: spoke in support of motion. Mentioned the Mayor's Green New Deal

Board Comment:

Ambriz: Motion to expand carbon mitigation measures to include others besides trees

Second: Stemar

Board Comment:

Hruska: this motion is specifically about trees, and their utilization in mitigating the 3 Climate issues cited. Adding any more parameters will kill it

Rubin: Concurred with Hruska

Tilson: Concurred with Hruska

Shure: Mentioned that other carbon mitigation measures are being incorporated into The city's Sustainability Guidelines
