**THE MVCC OPPOSES COUNCIL FILE 21-0863 UNLESS THE FOLLOWING CONDITIONS ARE MET:**

    1. HOUSING SUBSIDIES PAID FOR BY TAXPAYERS OF LOS ANGELES SHOULD NOT BE PROVIDED TO INDIVIDUALS WHO ARRIVED IN LOS ANGELES IN THE PAST 36 MONTHS.
    2. SUPPORTIVE HOUSING FOR INDIVIDUALS WITH SERIOUS MENTAL HEALTH ISSUES SHOULD NOT BE LOCATED IN RESIDENTIAL NEIGHBORHOODS WITH CHILDREN AND SCHOOLS WITHIN 1000FT.
    3. DRUG ADDICTION TREATMENT SHOULD BE REQUIRED FOR ANY INDIVIDUALS WITH DRUG ADDICTION IN ORDER TO RECEIVE TAX-PAYER SUBSIDIZED HOUSING.

PUBLIC COMMENTS FOR ITEMS NOT ON THIS AGENDA ***The Brown Act provides for a "part of the meeting where the public can comment on any item of interest that is within the subject matter jurisdiction of the local agency." The MVCC is an advisory board to the Los Angeles City council and, as such, its***

***jurisdiction is restricted within Los Angeles and most importantly, the Mar Vista Community. Therefore, please keep public comments within the MVCC jurisdiction. Thank you.***
