The bill requires the local authority to meet specified conditions to implement a slow street, including a determination that closure or traffic restriction is necessary for the safety and protection of persons using the closed or restricted portion of the street, conducting an outreach and engagement process, and clearly designating any restriction with signage.

Chair Paul outlined latest action on the Slow Streets program and solicited input from stakeholders.
