of the Neighborhood Council Ready Your LA Neighborhood (RYLAN) Liaison. The Mayor has set a goal of five RYLAN plans per neighborhood council. The draft, when ready, will be presented to the Neighborhood Council Emergency Preparedness Alliance. Currently, the department is preparing the Fiscal Year 2020-2021 Budget. With this budget the department is looking to address several areas: 1) Restructure the department to provide support to the Neighborhood Empowerment Advocates and the neighborhood councils, 2) Look at how grievances and complaints are addressed by forming a unit in the department dedicated to this, 3) Looking at centralizing translation interpreters, and 4) Build out the Office of Community Engagement Division that was been piloted this year. All City of Los Angeles departments are being asked to cut back in the proposed budget. As of November 15, 2019 Mrs. Beltrán has attended forty-four neighborhood councils on the Neighborhood Council Listening Tour.

Mike Fong, Director of Government and Policy, reported General Manager Raquel Beltrán has attended forty-four percent of neighborhood councils and over half of the alliances on her Listening Tour. Commissioner Lipmen, Commissioner Regalado, Raquel Beltrán and Mike Fong met with the Office of the City Clerk to discuss streamlining the neighborhood events request. As a result of the meeting D.O.N.E. and Commissioner Regalado set up an initial meeting with the Los Angeles County Department of Public Health to discuss how the City of Los Angeles can have a better working relationship. Mike welcomed Atziri Camarena to D.O.N.E. Mrs. Camarena will serve as a Neighborhood Empowerment Advocate in the Central and East regions of the City.

1. Submitting a boundary adjustment that shares facilities with the Westwood Neighborhood Council: Los Angeles Fire Department Station 37 (1090 Veteran Avenue), UCLA Outpatient Rehabilitation Services (1000 Veteran Avenue), the Westwood Branch Library (1246 Glendon Avenue), Westwood Recreation Center (which includes Westwood Park, Aidan’s Place, and Bad News Bears Field—1350 Sepulveda Blvd.) and Westwood Gardens Park (10853 Wellworth Ave. ).

The Department recommends that the Board of Neighborhood Commissioners:

1. **FIND** North Westwood Neighborhood Council’s request to change their boundaries consistent with the principles governing a Certified Neighborhood Councils’ purpose and operations per Article III 2(a) ii of the Plan for a Citywide System of Neighborhood Councils; and
2. **APPROVE** the change to the North Westwood Neighborhood Council’s bylaws to adjust its boundaries to share Westwood Recreation Center and Westwood Gardens Park with Westwood Neighborhood Council, as these facilities are designed for public use and are geographically compact and contiguous to NWWNC’s existing boundaries.

Commissioner Regalado reported in the Harbor area there are two parks (County/City) located adjacent to each other. A Wild Fest event was coordinated between both parks. A partnership was solidified with the Boys and Girls Club for pathways to employment. This program is focused on young people looking for Summer jobs as well as job interview preparation and resources. Looking to bring all Sustainability Committees together under one roof to speak with one voice as a region. Met with Los Angeles Unified School District local superintendent Mike Romero and highlighted the importance of local schools to work with their neighborhood councils.

Commissioner Vo-Ramirez recognized the Valley Emergency Preparedness Fair. Thanked all neighborhood councils that supported and participated at the fair during the course of an active fire. Staff were also thanked for being present and providing support to the venue. A Great Street Initiative grant was awarded for San Fernando Road and supporting the community's vision.
