  - Vishesh Anand (CD11) : Dodger Stadium will be used as a Covid-19 vaccine distribution center.

Treasurer

Zone 1 – Stacy Shure- expressed thanks to Councilmember Koretz for facilitating re-paving of Sepulveda Blvd. Seeing increases in crime. Working with LAPD to address.

Zone 2-Martin Rubin-seeing increases in crime and homeless encampments. Expressed hope that, with the coming election, more stakeholders would become involved with addressing these issues

Zone 3-Mary Hruska- see written report

Zone 4- Robert Watkins, MD-see written report. Additionally mentioned that Covid-19 poses far more risks than the vaccine does.

Received several emails in opposition to agenda item 14.6 on the basis that they feared this would be effectively changing the use to commercial.

- Zone 5-Michelle Krupkin-crime increasing, particularly car-related. Car accident at Venice and Ocean View. Homeless encampments increasing. As seeing more RV's as well. Mentioned that Councilmember DeLeon has proposed an audit of Measure HHH spending, Mar Vista Post Office currently has 18 carriers for 36 Routes. Working with Rep Bass on this issue. Working with stakeholders residing in the Oval to create Historic Preservation of the area, possibly with the Mar Vista Historical Society and the LA Conservancy
- Zone 6-Holly Tilson- concerns regarding crime, but overall, zone 6 residents seem to be coping and upbeat

Zone 7-Krishna Curry : hosting a meeting on Feb 2 for Zone 7 residents who wish to form a Homeowners Association. Mentioned an article in the Venice Current regarding Charles Edward Aragon, the Zone 7 stakeholder killed in an altercation with a homeless person. Mentioned the family members who survive him, his work as a veteran, and the many memories residents of Zone 7 have of him.

Ad Hoc Covid -19 Committee- met with Freddy Cupen-Ames and Julien Antolin regarding Issues relating to approval of lists and documents and meeting scheduling. Have met with Vishesh Anand regarding how committee can work with CD11 and will contact CD5 as well. Have submitted paperwork to City Attorney regarding [using voter rolls to] contacting seniors. Have recruited 7 volunteers via community groups to assist with this. Are utilizing training algorithms that Palms and Los Feliz NCs have used. Are compiling a list of hyper-local resources. There is a google forms link for contributing to this on the committee page. Next committee meeting is Jan 23 at 2PM. Volunteer training sessions Jan 27 and Jan 30. Elections and by-Laws- NC election date: June 8, 2021. Election will be vote by mail only. Must register to vote and then request a ballot.

Candidate registry window Feb 6-March 23, 2021. Working to hold a Candidate Forum In May, prob May 15 or May 22<sup>nd</sup>. Will probably be a ballot drop off box at Mar Vista Park but this is not yet confirmed.

Transportation and Infrastructure-had very informative presentation by LA Sanitation last meeting. Hoping the Mar Vista Historical Society can weigh in in Downtown Mar Vista Beautification Project.

Planning and Land Use (PLUM)- Projects coming to PLUM: 11961 Venice Blvd (5-story, multifamily) which has already received approval but has not yet presented to MVCC PLUM. Eight unit RSO was demolished on Berryman. 12725-27 Zanja has a proposed Preschool. Lot has been cleared of 13 trees. Project has problematic curb cuts. Will also be addressing State bills ACA 1 and 2 and SB 5 and SB 6.
