LAPD/CPAB Report

- Senior Lead Officer updates (Crime trends, CompStat numbers) Officer Officer Hector Aceves (L.A.P.D.) briefed latest crime statistics – Burglaries have increased. He warned against complacency (open windows, etc.).
- Block Capt. Program (where we are numbers wise and goal setting for future community involvement) – Nothing to report but Officer Greg Jacobus (L.A.P.D.) discussed the formation of a neighborhood watch and ways of increasing neighborhood watch participation.
