WHEREAS Santa Monica ballot Measure D provides for a vote of the people to decide the fate of the Santa Monica Municipal Airport, removing this decision-making power from the Santa Monica City Council, but does not address any of the issues aforementioned.

WHEREAS Santa Monica ballot measure LC does address the aforementioned issues and places the power to decide how the land would be used should the Santa Monica Municipal Airport be closed into the hands of the voters.

THEREFORE the MVCC urges the City Council of the City of Los Angeles

to publicly come out against Santa Monica City ballot Measure D and in favor of Santa Monica City ballot Measure LC.
