## Letter of Appreciation to the Santa Monica City Council

The Mar Vista Community Council would like to express its appreciation to the Santa Monica City Council for its recent decision to add Section 10.04.06.150 to the Santa Monica Municipal Code. We are in complete agreement that, for the safety of all residents---both in Santa Monica and Los Angeles---living in close proximity to the airport, it is important to conform the usage of the Santa Monica Airport to category A and B aircraft.

Furthermore, we would like to commend the Santa Monica City Council for its courage in passing this ordinance in the face of stated opposition from the Federal Aviation Administration. The MVCC will strongly support any action taken by the Santa Monica City Council to pursue all state and federal legislative means to also accomplish the goals of this ordinance, if such means become necessary.

# Motion Urging the Los Angeles City Council to Express Support for the Santa Monica City Council Vote to Limit Usage of the Santa Monica Airport

The Mar Vista Community Council requests that the Los Angeles City Council consider a resolution expressing support for the Santa Monica City Council's recent decision to conform usage of the Santa Monica Airport to the Category A and B aircraft which the airport was designed to accommodate. The MVCC suggests adoption of the following:

Whereas the City of Los Angeles is concerned for the health and safety of its residents who live in close proximity to the Santa Monica Airport, and

Whereas those residents of the City of Los Angeles who live in close proximity to the Santa Monica Airport are very concerned about the possibility of a catastrophic accident in our neighborhoods in the event of a jet aircraft's mishap during takeoff or landing, and

Whereas the Santa Monica Airport as currently configured has no Runway Safety Areas for the larger and faster jets taking off and landing at the airport,

Therefore, The Los Angeles City Council expresses its strong support of the Santa Monica City Council for its recent unanimous vote to pass SMMC 10.04.06.150, which conforms usage of the Santa Monica Airport to the Category A and B aircraft which the Airport was designed to accommodate.

And the Council strongly urges the Federal Aviation Administration to cooperate with the implementation of the Santa Monica ordinance.
