In early 2015, community advocacy groups from New York, Boston, Chicago, Phoenix, Minneapolis-St.Paul, Los Angeles and Palo Alto started a national discussion to join efforts to address noise and emissions problems arising in our communities from FAA's Nextgen project.

By the Spring of 2015, we set national <u>goals</u>, and a clearinghouse of information via a Google forum. We've worked together to exchange ideas, suggest <u>legislation</u>, lobby Congress, and represent our coalition at national meetings. Our goal now is to more formally align the interests of advocacy groups nationwide and strengthen our representation. QSC will connect with national leaders, elected officials and aviation stakeholders on national issues.
