<u>Old Business</u> – Progress Reports & Further Discussion of tabled items from the May 17th Meeting:

Item #1: Follow-up report from Rudy G. re: his study to put a left turn signal at Sawtelle and Charnock, between the signals at Sawtelle/Palms and Venice Blvd., to enable drivers to make a left turn at the 4-way signal at the Sawtelle/Charnock intersection. **[LADOT]** 

Item #2: Follow-up report by Rudy G. re: a request for traffic mitigations/study/enforcement for Palms Blvd. at Greenwood Ave. due to many serious accidents and both pedestrian and animal fatalities due to speed and visibility issue at this curve in the road, and as to his planned study of this location for an all-way STOP at Greenwood and Palms to slow traffic in this section. **[LADOT]** 

Item #3: Follow-up report from Rudy G. re: his study of stakeholder request to install a STOP sign at the street corner of Maplewood Ave. and Lucille Ave. on the Lucille side facing east and west. **[LADOT]** 

Item #4: Follow-up report by Rudy G. as to the date when a STOP sign which was granted and approved for Marcasel Ave. to help control a speeding problem on that street was or will be installed. **[LADOT]** 

Item #5: Follow-up report by Rudy G. re: a planned study of a stakeholder request for a 4-way STOP at the intersection of Barry/Colbert and Federal, to replace a 2-way STOP for traffic on Barry/Colbert, to improve visibility of oncoming cars on Barry. **[LADOT]**

# **Other Agenda Items:**

## Old Business -

No unresolved Old Business items were tabled or carried over to this meeting from the May 17, 2017 meeting.

### <u>New Business –</u>

Item #1: A stakeholder urgently requests that street lights be installed on Victoria Ave. between Walgrove Ave. and Beethoven St. as there presently are no street lights. Stakeholder says the street is "super dark" at night and it is a matter of nighttime safety for residents on and visitors to this street. **[CD11]** 

Item #2: A stakeholder/block captain who resides on Inglewood Blvd. says that Inglewood Blvd. between Palms and National has become a major pass-through street for northbound morning and late afternoon southbound traffic, with drivers disobeying speed limits and ignoring speed bumps, creating major problems with noise and vibration and causing cracks in some homes. Parking problems in this street have also resulted from apartment buildings on National and Barrington, whose managers provide

only one parking space per unit, and from the loss of some 40 street parking spots after traffic signal lights with left turn lanes were installed on National and Inglewood. Stakeholder says he has already reached out to LAPD Sgt. Acosta and CD11 Len Nguyen but the speeding and parking problems so far remain unsolved. **[CD11 & LAPD]**
