Approval of Minutes of March 28, 2018 Meeting.

Agenda Items for discussion are as follows.

LADOT Agenda Items: Old Business –

Item #1: Report/updates on an LADOT crosswalk study re: a stakeholder's request for a crosswalk at Barrington & Sardis, and also a DOT study for a possible traffic signal installation with a crosswalk at Sawtelle & Graham Place in 3-5 years if approved. **[LADOT]**

<u>New Business</u> –

Item #1: Stakeholder request for installation of a user-activated crosswalk at the intersection of Culver Blvd. and Slauson Ave. to enable pedestrians and bicyclists to cross Culver Blvd., using an already established route and correcting a neighborhood-devisive situation currently existing at this location. **[LADOT]**

Item #2: Request from a stakeholder living at 3667 Military Ave. for replacement of a speed bump about 20 feet north of her home which was paved over during street repaving at least five years ago and never replaced, resulting in traffic now speeding along this street. (Her calls to the City have gotten no response.) **[LADOT]**

Item #3: A stakeholder has reported that a left turn signal from Sepulveda Blvd. turning west onto Venice Blvd. never works during the most congested period at the intersection. Only one or two cars are able to make the turn before a green light requires yielding to oncoming traffic, so the turn signal is not programmed to be use-effective and the request is to fix it. **[LADOT]**

Item #4: Mar Vista Zone 6 Director reports that a "visible/zebra/continental sidewalk" is needed at the Greenwood/Palms Blvd. intersection on Palms because cars roll right over the pedestrian crosswalk, marked with a single line at the STOP sign and not clearly visible, and requests that a more visible crosswalk be installed. **[LADOT]**

Item #5: Stakeholder reports a pothole in the "zebra" crosswalk on Beethoven St. at Palms Blvd. **[LADOT]**

Item #6: Customers of Beethoven Market at the Beethoven/Palms intersection have complained about waiting time on Beethoven causing traffic to back up north of Palms all the way to Walgrove Ave. during peak traffic times, possibly caused by cars turning left (east) on Palms, and request a traffic study to mitigate this traffic jam. [LADOT]
