The mission of the MVCC Community Plan Ad Hoc Committee is to engage Mar Vista stakeholders in the City of Los Angeles' Palms-Mar Vista-Del Rey Community Plan update. This would include issues of open space, development, infrastructure, transportation, public services, mobility, safety and maintenance of quality of life, as they relate to the Mar Vista Community Council Zones. Also included will be environmental issues relating to airspace, water conservation, design elements and the restoration and maintenance of the urban canopy. A primary goal of the Subcommittee will be to create an algorithm for the exchange of information between the Mar Vista Community and DCP. This will include the identification of a DCP contact as well as the establishment of a regular timeline and venue for exchanges between DCP and the Subcommittee.
