1. **Call to order**-meeting called to order by Chair, Mary Hruska at 7:42PM. 14 attendees.
2. **Adoption of the Agenda**-Motion to approve (Katherine Wheeler/April Petersen). Agenda approved without objection.
3. **Reading and Approval of Minutes**-motion to approve (Wheeler/Michelle Krupkin). Jan 26,2021 minutes approved without objection.
4. **Discussion and possible action on City Council File CF-20-1042**-motion approved on Feb 16, 2021, to update the zoning codes in the City of Los Angeles to streamline project approvals using a ballot measure.

The following motion was drafted for a Community Impact Statement:

The Mar Vista Community Council opposes any ballot measure which would obstruct the ability of communities provide input in their Community Plan update process.

The Transit Oriented Communities (TOC) ordinance has empirically demonstrated that they have underperformed if not hindered or reversed--the creation of affordable housing.

The current Regional Housing Needs Assessment (RHNA) cycle has witnessed a dramatic overproduction of market-rate housing and an equally dramatic underproduction of workforce and low-income housing.

The Community Plan update process offers the best opportunity for meaningful debate, engagement and education regarding housing and land use in the City of Los Angeles. Ballot and referendum processes have demonstrated susceptibility to undue influence by special interests.

Outmigration, vacancies and other housing trends precipitated by the COVID-19 pandemic have called the RHNA allocation to the City of Los Angeles into question and likely requires update or revision.

The residents of Mar Vista object in the strongest terms to the attempt to subvert the deliberative process that is the Community Plan update.

As such, the Mar Vista Community Council opposes Los Angeles City Council File 20-1042.

5. **Public Comment for items NOT on this agenda**-April Petersen mentioned that her daughter is doing a Community project and would like the opportunity to present it to the committee in the future. Hruska mentioned that she'd communicated with Dept of City Planning regarding the seeming incongruence of the department proceeding with the incorporation of proposed new citywide zoning code language (ReCode) in the Community Plan update while the ordinance in which these codes reside (the Policies and Procedures Ordinance) has not yet been approved. The response received was that the department was working under the assumption that the Policies and Procedures ordinance would be approved prior to the approval of the Community Plan.
