### 6. New Business

6.1 Mar Vista Renters Survey

Co-chair reviews the RES intention to produce and execute a 26-question survey to Mar Vista renters to better determine the demographic profile of renters, their needs, awareness of and engagement in the activities of the MVCC, and their wishes for community improvements.

VCD: [RES] could create a QR code on the flier/paper survey, cutting out the process of using a URL

Discussion about the survey questions:

VCD: Add ADU and condo question; maybe remove question about rent; add "street" questions before intersection to Question 2

TL: On Question 13, take out yeses and no's in responses

VCD: Remove the "I'm too busy" response from Question 14; asks if the word "relevant" in the third Q14 response is leading

TL: Agrees it's leading; change "relevant" to "specific"

VCD: Council in Question 15 could get confused with LA City Council

TL: Change council to MVCC?

VCD: Add LA City Council after City of Los Angeles [at the end of the questions]

VCD: Add unsheltered after homeless in Questions 15 so the response reads

"Homeless/Unsheltered"; take off Santa Monica Airport response, not relevant to renters; Combine "Mobility" and "Traffic" responses; separate education from arts and culture as responses TL: Take out mobility and traffic and add small business as a response VCD: In Question 20, the word "prohibit" in the question sounds accusatory TL: Change Question 20 last sentence to read "Do you currently have difficulty attending for one or more of the following reasons?" VCD: Clarify the meaning of micro mobility VCD: Add renters' committee [news] only option to Question 26 TL: Move to amend survey in manner enumerated hitherto VCD: Second No opposition VCD: Move to approve survey for continuation to the Outreach Committee TL: Second No opposition

### 6.2 Mar Vista Renters Survey Budget

VCD: Add Instagram ads to budget to reach more people; ability to geolocate; QR codes options TL: Take \$5 per day from Facebook ads for Instagram ads; QR codes are only roughly \$25 for each TL: Move to amend survey budget to \$1,017 for 600 flyer copies; \$300 for Facebook ads and \$300 for Instagram ads; \$25 for a QR code and \$10 for stock photos VCD: Second No opposition TL: Move to approve budget VCD: Second No opposition
