5.2 Discussion and Possible Action concerning California State Assembly Bill 15

This item is discussion and possible committee action on California Assembly Bill 15 (AB 15), which would extend the protections and penalties afforded by AB 3088, also known as the COVID 19 Tenant Relief Act of 2020, until January 1st, 2022. This bill would extend a landlord's liability to damages until January 1st, 2022 for unlawful eviction of a tenant who has declared COVID-19-related financial distress or interruption or termination of utility services. The "COVID-19 rental debt" definition given in the original (AB 3088) bill will be amended to apply to owed rent between March 1st,2020, and December 31st 2021. Finally, if the legislation becomes law, the 25 percent repayment requirement will extend from September 1st, 2020, to December 31st, 2021.
