ATTACHMENT 1 - SUBCOMMITTEE GOALS

- 1. Host a CERT-Express workshop at least once per year. If high level of interest, host full CERT training.
 - a. Hold 2019 CERT-Express workshop by June
- 2. Broadcast subcommittee efforts, resources, and events via Subcommittee newsletter and share at least one emergency preparedness event on the MVCC calendar each month.
 - a. 1 newsletter with: the next meeting + 1 event + 1 resource + recruitment call to action
- 3. Develop emergency preparedness 'resource center' on Subcommittee home page.
- 4. Establish at least one location in each Zone in Mar Vista as a physical resource for emergency preparedness and as an information hub during emergencies.
- 5. Lead at least two Map Your Neighborhood workshops per year, and establish at least 5 new Map Your Neighborhood leaders.
- 6. Develop database of CERT-trained residents/business owners in Mar Vista.
- 7. Connect Subcommittee efforts (and/or Map Your Neighborhood) with Block Captain program to take advantage of synergies.
