SECTION II - PROJECT DISCRIPTION

4) Please describe the purpose and intent of the grant.

In response to the COVID-19 public health crisis and L.A. County's Safer at Home Order, Westside Pacific Villages (WPV) developed the WPV CARES (COVID-19 Action Response for Elder Support) program. The program is to support older adults age 65+ and those most vulnerable to the virus who must shelter at home. This program is being offered FREE to the public. Seniors and others who must shelter at home may sign up for the program though WPV's website or by simply calling the WPV office. Once in our system, they may then contact the WPV office for help as described in #5 below. WPV volunteers are vetted through WPV's normal background, screening process, provided training, and scheduled for assignments through the WPV office system. This grant is to request funding to support this FREE program to residents of the Mar Vista Community Council footprint through at least the end of August 2021.

5) How will this grant be used to primarily support or serve a public purpose and benefit the public atlarge.

WPV has a nearly 10 year history of supporting older adults who want to age in the homes and communities they love. As a result, WPV was able to quickly adapt and offer its existing infrastructure to help those most impacted by the COVID-19 pandemic. Through our WPV CARES program, WPV is providing the following at no cost: 1) contactless pickup and delivery of groceries and essentials by vetted volunteers (not online ordering); 2) regular social support phone calls; 3) training on how to use technology to expand social connectivity options; 4) complementary weekly care packages and meal deliveries to brighten an isolated person's week; 5) Wellness @ Home program with tips, activities and encouragement to stay physically and mentally fit while sheltering at home; 6) virtual activities on a variety of topics; 7) limited transportation services. WPV also proactively assisted client members in scheduling COVID-19 vaccine appointments and provided transportation to/from vaccination appointments. This service is still available as needed. WPV has supported many parts of Council District 11 including the Mar Vista area. We currently have 30 active volunteers and 35 clients receiving services and would like to ensure all residents of the area are aware of this FREE program which we anticipate running for through at least the end of August based on L.A. County Public Health guidelines. While the City of Los Angeles offers similar services, WPV provides an additional option and has been able to respond quickly to the needs of community members. WPV volunteers also come from the local area which usually creates another valuable connection and commitment to those being served. If funded, and with the Mar Vista Community Council's (MVCC's) permission, WPV would like to incorporate the MVCC Seal on communications/marketing of this vital program and have the MVCC sponsor at least one of our weekly Friday deliveries to all WPV CARES clients. It is our desire to reach and continue to help residents of the MVCC footprint and are asking for funding to continue to support this effort. While WPV is a volunteer-driven organization, it has a small part-time staff who has been working tirelessly and volunteering their own personal time to coordinate the increased volume of


volunteer screening, training, client intake, client service requests and coordinating all the efforts required to run this FREE program to the community.

Since being awarded the grant last year, WPV added 10 new MVCC residents who have been receiving services and sadly 2 MVCC residents passed away. WPV recruited and screened 21 new volunteers from the MVCC area since being awarded this grant, however, not all are currently actively volunteering at this time.

 - WPV's slogan is "Neighbors Helping Neighbors" and the village concept is built on the simple premise of just that neighbors of all ages helping their older adult neighbors in the community so they may continue to enjoy and remain in the homes and neighborhood they love. WPV enables the oldest MVCC residents to remain and age in the community and this is done by building a trusted network of support. Older adults, their families and the community at large benefit from this. 


