PURPOSE: Amend Standing Rules 7.1 & 7.2

BACKGROUND:

STANDING RULES - Current Language:

7.1. All Board and committee agendas shall include a standing agenda item for the "Declaration of Ex-Parte Communications and Conflicts-of-Interest" by each present MVCC board member, committee chair or co-chair.

7.2. Ex-Parte Declarations must be noted in the official minutes of meetings, including details such as meeting dates, identities of the participants, and the substance of the communication.

STANDING RULES - Proposed Language:

7.1. All Board and committee agendas shall include a standing agenda item for the "Declaration of Ex-Parte Communications and Conflicts-of-Interest" by each present MVCC board member, committee chair or co-chair.

7.2. Ex-Parte Declarations must be noted in the official minutes of meetings, including details such as meeting dates, identities of the participants, and the substance of the communication-if provided by board member.

Every board member is required to complete 6 hours of training including ethics and conflictsof-interest, and the Department of Neighborhood Empowerment (DONE) has declared that any ex-parte and conflict-of-interest declaration is on the honor system and is the responsibility of each board member. Thereby, each director is already trusted and should be trusted to act according to that training at all times, including at committee meetings and a mandatory declaration item on a committee agenda is not necessary.

Committees are where stakeholders come to express their viewpoints and provide input on community matters. The motions that come from committees have no mechanism for action other than to go to the Board. Any attending board member (if not a Chair of the committee) is attending as a stakeholder and not as a board member and should be treated equally as other stakeholders.

The Department of Neighborhood Empowerment (DONE) does not require Neighborhood Councils (NCs) to place on any agenda (including a Board agenda) an item for "ex parte" or "conflict-of-interest". - See Exhibits A & B

All neighborhood and community councils on the westside are members of the Westside Regional Alliance of Councils (WRAC). WRAC is "a cooperative regional coalition of councils, made up of 14 neighborhood and community councils on the Westside of Los Angeles"¹.

Among all 14 WRAC members, the Mar Vista Community Council and the Venice Neighborhood Council are the only ones that place a declaration of ex parte and/or conflicts-of-interest on the Board Agenda. - See Exhibits C, D, E, F, G, H, I, J, K, L, M, N, O

The first MVCC Board Agenda to have an item for "ex parte" and/or "conflict-of-interest" was December 2017. - See Exhibit P, Q, R, S, T, U, V, W

Out of the 11 committees that have met this year from Venice Neighborhood Council, only 1 had an agenda item for a declaration of ex parte and/or conflicts-of-interest and that was a Joint Meeting with the Board of Directors. - See Exhibits L-01 thru L-11.

It wasn't until 2021 did any current MVCC open-to-the-public committee comply with Standing Rules 7.1 & 7.2. And none of the 15 archived committees or subcommittees ever complied with these Standing Rules.

Therefore, the Standing Rules should changed to conform with the history and precedent of the MVCC to continue committee meetings that are open, inviting, and friendly to encourage stakeholder participation as the MVCC's purpose is to promote more stakeholder participation in government.

THE MOTION:

The MVCC approves changing the Standing Rules to the following:

7.1. All Board agendas shall include a standing agenda item for the "Declaration of Ex-Parte Communications and Conflicts-of-Interest" by each present MVCC board member.

7.2. Ex-Parte Declarations must be noted in the official minutes of meetings, including details such as meeting dates, identities of the participants, and the substance of the communication if provided by board member.

PROCESS FOR RECONSIDERATION: [Meeting attendees should be made aware of the process in your bylaws, which a vote by the Board can be reconsidered. The following is an example of language that you may use to describe the reconsideration process, however, you must ensure that, if you use this example, it is consistent with your bylaws:]

The Board may reconsider or amend its actions through the following Motion for Reconsideration process:

1. The Board's approval of a Motion for Reconsideration must occur within the following specific periods of time: The Motion for Reconsideration must be approved either:

(a) during the same meeting where the Board initially acted; or

(b) during the Board's next regularly scheduled meeting that followed the meeting where the action subject to reconsideration occurred.

These specified time frames do not prevent the Neighborhood Council from convening any special meetings within the specified time frames to address a Motion for Reconsideration.

2. Before the Board reconsiders any matter, the Board must approve a Motion for Reconsideration. The Motion for Reconsideration must be approved by official action of the Board [*OR INSERT HOW the Board takes official action, e.g., a majority of the Board Members present...*] After determining in the affirmative that an action should be reconsidered, the Board then has the authority to re-hear, continue, or take action on the item that is the subject of reconsideration within any limitations that are stated in the Motion for Reconsideration.

3. The Motion for Reconsideration shall only be proposed by a member of the Board that previously voted on the prevailing side of the original action that was taken by the Board (the "Moving Board Member"). The Moving Board Member may make the Motion for Reconsideration by either:

- (a) an oral motion that is made during the same meeting where the action that is the subject of reconsideration occurred, or
- (b) by properly placing the Motion for Reconsideration on the agenda of a meeting that occurs within the allowed specified periods of time as stated above.

4. If the Motion for Reconsideration is made subsequent to the meeting where the action that is the subject of reconsideration occurred, then the Motion for Reconsideration must be on that subsequent meeting's agenda. The Moving Board Member places a Motion for Reconsideration on the agenda by submitting a memorandum to the ... [whoever creates the agenda ...e.g., Secretary...] at least ... [Specify a Time line, e.g., two days in advance of the deadline for posting notices for the meeting....] The Moving Board Member's memorandum must briefly state the reason(s) for requesting the reconsideration, and provide the [...Secretary...] with the language necessary to complete the

information that must be stated in the agenda. The language that must be stated in the agenda is an adequate description of the:

- (a) Motion for Reconsideration and its description of the item that is to be re-heard; and
- (b) A proposed action that may be adopted by the Board if the Motion for Reconsideration is approved.

5. When the Motion for Reconsideration is brought before the board for consideration, then that motion may be seconded during the public hearing by any member of the Board.

6. This reconsideration process shall be conducted at all times in accordance with the Brown Act, including that: any discussion on the issue remain within permissible discussion parameters; that any decision is made during the public hearing; and that, if the Motion for Reconsideration is considered at a subsequent meeting to the meeting where the act that is the subject of reconsideration occurred, then the Motion for Reconsideration is properly listed on that meeting's agenda.

PROCESS FOR FILING A GRIEVANCE: [Meeting attendees should be made aware of the process in your bylaws to file a grievance against the neighborhood council and notified of the ability to file a complaint with the Department of Neighborhood Empowerment. The following is an example that may be used as long as it is consistent with your bylaws]

Any member of the public may file a grievance by submitting a writing containing the nature of the person's complaint to the Secretary of the Neighborhood Council. The written grievance will then be referred to a grievance committee comprised of five (5) Stakeholders who are randomly selected by the Secretary from a list of Stakeholders who have previously expressed an interest in serving from time-to-time on such a grievance committee. Within fifteen (15) days of referral, the Secretary will coordinate a time and a place for the committee to conduct its public meeting with the person(s) submitting a grievance and to discuss ways in which the dispute may be resolved. The grievance committee will prepare a report and recommendation to the Board to be heard within fifteen (15) days from the date of the grievance committee's meeting. The Board may receive a copy of the panel's report and recommendations prior to the meeting by the Board, but the matter shall not be discussed among the Board members until the matter is heard at a meeting of the Board pursuant to the Brown Act.

This formal grievance process is not intended to apply to persons who disagree with a position or action taken by the Board at one of its meetings. Those grievances can be aired at Board meetings. This grievance process is intended to address matters involving procedural disputes, *e.g.*, the Board's failure to comply with Board Rules or these Bylaws, or its failure to comply with the City's Charter, the Plan, local ordinances, and/or State and federal law.

In the event that a grievance cannot be resolved through this grievance process, then the matter may be referred to DONE for consideration or dispute resolution in accordance with the Plan.

BROWN ACT REVISION AND LANGUAGE IN THE BYLAWS

The City Attorney wishes to bring to your attention a recent *amendment to the Brown Act^{*} that takes effect on July 1, 2008,* and impacts the *wording of board agendas* and also impacts how the *records*, which are reviewed by board members in anticipation of a meeting, are to be *made available to the public*. This information is intended to provide you with guidance in preparing the agendas for the Neighborhood Councils.

The pertinent amendment is contained in Government Code section 54957.5 paragraph (b) reads as follows:

"(b) (1) If a writing that is a public record under subdivision (a), and that relates to an agenda item for an open session of a regular meeting of the legislative body of a local agency, is distributed less than 72 hours prior to that meeting, the writing shall be made available for public inspection pursuant to paragraph (2) at the time the writing is distributed to all, or a majority of all, of the members of the body.

(2) A local agency shall make any writing described in paragraph (1) available for public inspection at a public office or location that the agency shall designate for this purpose. Each local agency shall list the address of this office or location on the agendas for all meetings of the legislative body of that agency. The local agency also may post the writing on the local agency's Internet Web site in a position and manner that makes it clear that the writing relates to an agenda item for an upcoming meeting.

(3) This subdivision shall become operative on July 1, 2008."

Typically, board members receive an agenda and written materials to review in advance of a meeting (the "agenda packet"). Government Code section 54957.5 clarifies that once the writings or agenda packet are delivered to a majority of the members on the board, the records, unless specifically protected from disclosure by the Public Records Act, must be made immediately available upon request. If written materials are submitted to the board after the posting of the agenda, then the agency shall designate a location (and an optional website link) where the public may view the records.

Therefore, Neighborhood Councils should provide for easy access to the records by making them available on the website in addition to a physical location. It will be important to insure that upon distribution of the agenda packet to a majority or all of the board members, the documents are promptly placed in the correct location and posted on the website.

[Pacific Palisades Community Council (PPCC)] urges Councilmembers Bonin, Koretz, Raman and Ridley-Thomas (Councilmembers representing WRAC Member-Councils) to consult as soon as possible with their respective WRAC Member-Councils for input as to the designation of sites within their districts for enforcement pursuant to LAMC Sec. 41.18(c)(1)-(4) and 41.18(d), including: 1) schools, day care centers, public parks and public libraries, as defined in LAMC Sec. 105.01 ("sensitive uses"; 41.18(c)(1)); 2) overpasses, underpasses, freeway ramps, tunnels, bridges, pedestrian bridges, subways, washes spreading grounds and active railways, when public health, safety or welfare is served by the prohibition (41.18(c)(2)); 3) designated facilities opened after January 1, 2018 that provide shelter, safe sleeping or safe parking to homeless persons or that serve as homeless services navigation centers (41.18(c)(3)); 4) any locations in public rights-of-way for which there is documentation of a "particular and ongoing threat to public health or safety" (41.18(c)(4)). No enforcement actions shall be taken unless the individuals have been offered shelter and have refused the offer.

Also consider the Culver City Farmer's Market. Josh says he has interacted with the folks who run the Mar Vista Farmer's Market and believes they would let us participate. Clean Air Pledge? Sign up for trees from City Plants? Ask people what environmental issue they are most passionate about? Signup sheet to connect with the Green Committee. Business cards with email addresses. Green Business Ambassador Program – Dept of Sanitation should be providing materials, Jessalyn will see if she can get materials from them. Helen says with Delta we probably don't want to do art with kids. Josh suggests giving out TAP cards. Maybe give out vouchers for bikes? Ask the Transportation Committee if they can provide assistance with that? Natasia says her former employer offered vouchers and they got reimbursed for it. Jessalyn says she will take on that task and try to figure it out. Charles says Jay Greenstein is Koretz's transportation person and would be the right one to reach out to. DOT has done free days on the bikes and it is kind of a mess getting people to use the bikes.

- d. Charles Miller update on his work with NCSA, and EV pilot project
 - 55% of LA is multi-family housing, most is small multi-family. Unlike a house which can take more electrical load, each apartment is its own power source and DWP wants you to put the chargers on that systems and those are often maxed out. Palms has the highest percentage of this type of housing anywhere in LA. 60% built before 1970. Started working on the UCLA sustainability program on it. He wants us to sign off as being the test case. In the next month he will put together a powerpoint that will be 10 minutes. NCSA can use it as part of their materials too. The outreach would be to renters, building owners, managers, HOA owners, etc. It would be a Palms NC branded presentation on how to get EV chargers into those buildings. One in five EV owners have moved back to traditional vehicles because they couldn't get charging at home. He approached 26 vendors and all but three refused the project because it is so difficult. He asks for us to sign off on the idea of doing a seminar in connection with a GA meeting or at one of our meetings or in a special meeting. The last thing we want to do is to have a building owner or HOA try to facilitate to EVs and then run into bureaucracy and give up. Charles says they still haven't gotten the chargers in and they don't even have a garage yet. They just got engineering approved by DWP last week. They have to apply for the incentive program; the next time they are accepting the submissions is September. Hoping to have them installed by the end of the year. Natasia asks what incentives there are for landlords to put in the units and how much more will they be paying? Charles says 94% of the cases the building owner can use the incentive program and not be out of pocket. \$4,000 rebate for every charger installed. For every 4 parking spaces, you qualify for a rebate. They are all set up on smart chargers. They are connected to the internet – everyone has an account and it is connected to an app with a credit card.
 - Clarifying what we are committing to? Branding, an event, presentation, etc. We would need to vote on it in our meeting and in a board meeting. His timeline is to have it done and signed off on by NCSA, UCLA, etc. by first week of September. He can have the materials ready by September 14th for our next meeting.

Whereas the Venice Coastal Zone should contribute to the needed increase in density.

Whereas the Venice Coastal Zone already has stricter commercial and residential parking requirements than the rest of the City of Los Angeles.

Whereas the Venice Coastal Zone Specific Plan requires that all new vehicular access to Venice Coastal Development Projects shall be provided from alleys, when available.

Whereas the Venice Coastal Zone lots are mostly Substandard Lots, therefore, creates a hardship to provide the additional one (1) onsite parking stall currently requested by The City of Los Angeles and the California Coastal Commission.

Therefore the Venice Neighborhood supports the use of public transportation as described in AB 68: (d) Notwithstanding any other law, a local agency, whether or not it has adopted an ordinance governing accessory dwelling units in accordance with subdivision (a), shall not impose parking standards for an accessory dwelling unit in any of the following instances:

(1) The accessory dwelling unit is located within one-half mile of public transit.

(2) The accessory dwelling unit is located within an architecturally and historically significant historic district.

(3) The accessory dwelling unit is part of the proposed or existing primary residence or an accessory structure.

(4) When on-street parking permits are required but not offered to the occupant of the accessory dwelling unit.

(5) When there is a car share vehicle located within one block of the accessory dwelling unit.
