Summary: The Mar Vista Community Council opposes CF 22-0158. Reports consistently show the direction of future city action. Removing community review of homeless projects should not be considered. Current LAMC provides for temporary and permanent homeless shelters. As with all building, zoning is an important component and it provides for public and community input before approval. Changing zoning codes would supplant the years of work and accomplishments on the Community Plan Updates and irrevocably change them without public input. Making temporary shelters permanent by right would be a slap in the face to stakeholders who trusted elected officials that the shelters would not be made permanent without prior public input.
