Traffic (e.g., Venice Blvd. Road Diet)

Various other issues Candidate champions

2 minutes - follow up

3 minutes - closing statement

Some issues of concern (in alphabetical order) to stakeholders and the Mar Vista Community Council Board of Directors include:

- *Communication and relationship between the Council member and their Neighborhood Councils*
- *Crime and the lack of enforcements of ordinances - i.e., the leaf blower and fireworks ordinances as well as speeding, donut circles takeovers, and lack of parking enforcement.*
- *Development and its effects on the environment and infrastructure*
- *Homeless encampment situation*
- *Traffic (including the Venice Blvd. Road Diet)*
- *Various other issues that you as a Candidate champion*

There will be no specific questions from the MVCC BOD and viewers.

However, we ask that each candidate include a list of their issue priorities and speak about how they plan to deal with each, including specifics relating to Mar Vista.
