- 1. CALL TO ORDER 6:08PM
- 2. ROLL CALL AND EX-PARTE COMMUNICATIONS/CONFLICTS-OF-INTEREST Roll Call shall include each attending board member declaring any ex parte communications outside of their duties and conflicts of interest pertaining to items on or related to this agenda. - 3. WELCOME AND ANNOUNCEMENTS
 - 3.1. Update on the Venice Blvd. Mobility Project
 - 3.1.1. After the last board meeting, We had a meeting with LADOT about updates They did a traffic study on Venice and discovered a big cause of traffic is between Sepulveda and Sawtelle intersections around 405. They made two changes to the plan to address this: Installing double turn lanes at both intersections. They took out the rapid bus lane between Sepulveda and Sawtelle. The one other change is that they are changing the parking protected bike lane from Inglewood to the 405 to buffered protected bike lane due to too many driveways.
 - 3.1.2. Construction Schedule Early December: LADOT will begin installing striping on Venice Blvd between Inglewood Blvd & Sepulveda Blvd. Mid-December- January 2023: StreetsLA will repave Venice Blvd, between Sepulveda Blvd & Motor Ave. Resurfacing will tentatively take place on Saturdays with the exception of holiday weekends, in which case paving will take place on a weekday. Late January- February 2023: Street restriping and project installation continues. March 2023: Anticipated completion of striping, pavement markings, signage, and bollards
 - 3.2. Tree Removal Notification from Urban Forestry Division
 - 3.2.1. The board got a public notification from the Urban Forestry Division (UFD) about a tree removal request the UFD has received for a tree at 3560 S Greenwood Ave. Any individual or your Neighborhood Council can weigh in on the removal of the tree. If our Neighborhood Council elects to take official action, we can submit a letter to either Hector Banuelos or the Board of Public Works. The Urban Forestry Division (UFD) does try to avoid tree removals,

particularly when there is no safety concern related to the tree, but objections by members of the public or a Council Office will be received by UFD. Those choosing to file an objection are recommended to include a course of action that includes an understanding of the tree's health and condition are more likely to have an impact. If the removal is for 1 or 2 trees, the UFD prefers that Neighborhood councils raise objections within 3 days. In most cases, however, you have about 30 days to send in any objections to the removal. Just because a removal is being requested through this process does not indicate a decision has already been made. You are receiving this notification because the tree removal request has been elevated to the Chief Forester, who will be making the final decision. The Department of Neighborhood Empowerment recommends that Neighborhood Councils establish an Ad Hoc committee of up to two board members authorized to respond to tree removal notifications on behalf of the Board in these instances.

- 4.  - 6.2. Vice-Chair Faith Myhra -
 - 6.2.1. Update on Getting Speed bumps on Wade St: Our application for speed bumps on Wade St. between Venice Blvd and Washington Blvd has not been accepted as LADOT reached their capacity to accept applications into the current cycle. I will resubmit during the next open application day which they anticipate will be mid year of 2023.
 - 6.2.2. Sepulveda Transit Corridor: The environmental process is continuing and is expected to generate an inclusive vision that balances the unique needs of diverse corridor stakeholders through ongoing dialogue with project stakeholders and communities. Metro will be hosting its next set of community Open House meetings in early 2023, which will focus on potential station locations and how to access this future transit system.
 - 6.2.3. EV Charging Update: Each year, the Bureau of Street Lighting receives an allocation for new Level 2 chargers that can hang on street light poles. Usually, they work with Council offices near the beginning of the fiscal year to identify promising locations. We should identify locations in Mar Vista that are good candidates and share that list with the new CD11 office sometime in the spring next year. They have historically tried to put the on-street chargers in multifamily neighborhoods where residents are less likely to have home charging.

- 6.3. WRAC Report Andy Perrine Meet in November and had a productive meeting around 3 different propales around digital signage programs and other things through Metro and the City. One motion was regarding billboards and other advertising. This motion was tabled as there were some concerns and the committee wanted to get report later and will possibly revisit. The second motion was regarding the IKE (interactive kiosk) program which is on our agenda for tonight and was passed at WRAC MTC. The third motion was regarding Bus Lane Violation Enforcement which is also on our agenda for tonight and was passed at WRAC MTC.
