Faith Myhra with Neighborhood Council Sustainability Alliance: NCSA has taken a position against the gondola project. Timeline: the goal would be to complete it before the Olympics. The local community would suffer greatly from this project after already having been hurt by Dodger stadium in the past.

There will be a demonstration lawn conversion on March 9 and 10.

There will be a meeting put on by Climate Reality Project about sustainability in the LA River.

There is an EV motion being discussed at the next committee meeting.

The tree committee will be meeting Saturday March 23, crafting a new tree campaign for the city.

8.1.[ADMINISTRATIVE] RESILIENT PALISADES PRESENTATION. Discussion and possible action regarding how Resilient Palisades has pursued solar and storage adoption and microgrid initiatives in their neighborhood.

Ryan Craig presented and responded to questions from the committee and stakeholders. He is the cofounder and treasurer of <u>Resilient Palisades</u>, an organization in the Palisades devoted to combatting climate change through local action. The organization raises money through donations and the California CORE state program to get funds to provide electric leaf-blowers for gardeners. They worked in partnership with their local community council. Feel free to reach out to <a href="mailto:ryan@resilientpalisades.org">ryan@resilientpalisades.org</a> with any questions.

The solar effort by the organization is about 2 years old, this is meant to make the transition less complicated for community members. Battery storage dramatically increases the utility of rooftop solar so that it can even work at night. Phase 1 is to increase the penetration density of solar and storage through a group purchasing program. Then they could go door to door to try and convince people to switch to solar. The potential installers had to agree to certain terms including responsiveness guarantees and warranties. Then they had events reaching out to the community to try and increase adoption. The installers agreed to pay a commission to Resilient Palisades for their extensive outreach efforts. 150 people have requested installation and 45 have received it. Most people are buying, not leasing. Did a full mailing to every household and additional door-to-door outreach. Only single family homes so far have been able to get installations. The biggest obstacle to people is the up front cost, usually in the realm of \$20,000. The installers do offer financing options.

They have also focused on eventually creating a microgrid that would use homes with solar panels and battery storage that can support each other to provide power if the full power grid went down. There are very few microgrids yet in existence in residential areas.

Changes to net metering proposed by CPUC would significantly reduce the incentives of rooftop solar. This organization came before the community council. Reach out to ryan@resilientpalisades.org.

# 8.2.[POLICY] COUNCIL FILE 24-0055 (GAS-POWERED LEAF BLOWERS / FISCAL YEAR 2022-23 COMPLAINTS AND CITATIONS / ENFORCEMENT / EDUCATION PROGRAM).

Discussion and possible action regarding <u>Council File 24-0055</u> regarding data collection, improved enforcement, and educational outreach on gas-powered leaf blowers.

Gas leaf blowers are known to be polluting and have been banned for many years, yet LAPD is not enforcing the ban on certain leaf blowers.

Jakob moves to support the council file motion / Kelsey seconds

The motion mentions a \$250 rebate for turning in a gas leaf blower for an electric one. One potential challenge is that the cost of an electric leaf blower is about \$3,500 so the rebate does

not cover it. To use electric leaf blowers for a full day of work, gardeners would also need two batteries and a charger. There used to be additional rebates from CORE but it has run out of funds.

Another challenge is the pushback from gardeners who don't like the concept of switching and people interfering with their work.

The third issue is that some electric leaf blowers produce more high pitch noise than gas powered leaf blowers.

The motion instructs that the Bureau of Street Services explore a potential tiered fine system for repeat offenders issued to the owner of the property rather than the gardener.

April does not support the menu of options listed in the motion about new enforcement mechanisms. The committee and stakeholders feel that there are many potential problems with the enforcement mechanisms listed.

One stakeholder supports the idea of a study but not the idea of only having "sticks" rather than "carrots".

Kelsey points to the language of the motion, indicating that these enforcement mechanisms are recommended to be studied and not necessarily implemented, and also doesn't prefer the LAPD enforcement and basing potential fines on neighborhood gossip. Despite those drawbacks, however, the motion is worded to explore potential mechanisms to disincentivize the use of gas-powered leaf blowers and views this as a step in that direction.

In addition, and most importantly, we are extremely concerned about the lack of transparency around this process and request that LADOT report back to neighborhood councils about the number and location of requests, the prioritization of those requests by LADOT, and the order in which approved requests are to be implemented."
