Comments Discussed:

Della XXXX from Richland Booster club presented NPG.

Vanek commented about procedure for NPG and others have been refused and asked about timing, are we in the new budget year.

Mack asked about materials being vetted through LAUSD process of permissible materials. Vendor is LAUSD approved vendor (according to Della).

Honda said schools are different than the baseball field.

Public comment: Questions about soil being tested. Question about why city hasn't paid this already.

Ahmadyveasi asked about a plan for the rest of the funding; they have \$3K remaining from last year, only need about \$1000.

Motion: Mack motions to approve NPG as submitted. Vanek seconds. Honda and Ahmadyveasi abstain.

7.2 [ADMINISTRATIVE] Discussion and potential action regarding Palms Art Figures & DWP Comments Discussed:

Three sets of speakers: artist, DWP, and a note from Traci Park's office.

Lori Powers (artist) – Explained she has been putting up art on DWP poles without permission for ten years. Started the art to give back to her community. They were metal guitars with messages and a whimsical characters. Put first one up, waited nine months before doing more. Continued adding them, and could see community was appreciating it. Like to leave it as a mystery as to who was doing it or why. Didn't let anyone know she was doing it.

Last week got call from LADWP to take art down.

They are there for everyone and free—public art, no private sales. Reused and recycled materials.

How did this happen? How can we make a partnership?

Heard from Matt Halden in Traci Park's office, and they said they were talking to LADWP to delay the takedown. But LADWP came in this morning and took two down, but enough people stood at poles to prevent DWP from continuing. The two taken down were returned to Lori.

Thanked supporters, wants to continue art for community. Doesn't want to stop.

Honda left at 7:18pm.

LADWP presentation: Elena Stern and Paul Habib at legislation division.

Apologies for miscommunication. DWP wants to have conversation with Aritst and Park and sees this as collaboration. Art cannot happen on their powers. Regulared by Public Utiliites Commission. Nothing can be installed or hanging from these poles, but will work wth community to relocate them. Every day they are out of compliance, they will be fined that comes out of ratepayer dollars. DWP wants to work that everyone is safe, but something could happen. For safety of community, they have to keep poles clear. DWP commitment is to be a good community partner and tobe in compliance with state regulation and to help relocate her work.

They want to work with artist and CD11 for them to be displayed.

Ahmadyveasi reads comment email from Matt Halden in Traci Park's office.

Committee comments:

Mack – If voting on anything, it is to go to city council.

Public Comments:

Juan Fregoso in Traci Park's office in attendance to receive comments.

Donna Speckman: question to DWP on why it has taken so long? DWP responded that there was a formal complaint from someone in neighborhood, and they legally must respond. DWP follows state regulations and must keep poles clear. There is no grey area. Park's office wants to work with DWP to relocate them.

Heather McAdams – neighbor and teaching artist; her art is creating an open gallery for kids who normally cannot see art Sculptures creates a sense of community.

DWP emphasizes that if CPUC sees DWP out of compliance, they will fine DWP and the fines will be paid by consumers.

Max Powers (Lori's son) – appreciates the art, and enjoys the feeling it generates Aaron Thompson – challenges notion of it a hazard. Is this biggest priority of DWP? Look at regulations and find a way to make it work.

Paxton Farrar – art needs to remain in neighborhood. Concerned that DWP will take down with not replacement offered. DWP answered: they are looking at option to work with

CD11. They want to dialogue to find existing poles and or add poles. Fregoso in CD11 wants to also work with artist to make sure new locations are also compliant.

Nasim Thompson – believes general climbing area is on one side of pole only

Deirdre Breen – wants art to stay in neighborhood

Ray Cirino – problem can turn into a solution

Esther Rauclov – surprised DWP listened to a complaint. Art in this area is iconic. Does not want to see it become a myth.

Paul Van Blum – 35-year resident, UCLA professor, teaches Lori's work, remarkable, vibrant addition to community, cannot be allowed to disappear.

Alessandra Pasquino – do not keep works in one spot, keep in neighborhood, can authorities propose to us where they can put the sculptures?

lan Kimbrey – part of charm of art is that it is on telephone poles; does not understand the danger of art being on the poles. Are there dead utility poles that can be used?

Paige Morrow Kimball – filmmaker, made award winning 24-minute documentary about Lori Powers. Workers kept art and put them up on new poles. Suggests have another pole placed next to the current ones with a plaque. Lori has a safety chain is attached to each sculpture. Wants them to be maintained.

Dan Moroni – question about fines; but DWP just found out a few weeks ago, and they have regulatory obligation to investigate and put into compliance. Who made complaint? DWP cannot out the person.

Joe King – question about person withdrawing complaint, but DWP cannot rescind it if they do. Juan Fregoso says that banenrs nad wreaths can go on some poles through a permit process (but not DWP poles).

Eileen Erickson – loves the sculptures, and makes me drive slower in neighborhood. Does not want a second pole in front

Ryan Murphy – question about cameras on poles. DWP responds, yes, but that is installed by city. Fregoso corrects, that city has cameras on light poles, not utility.

Sara Darsky – ideas for motion to investigate hazards, and asks DWP not to remove art unless there is a place to go and keep it on Palms Ave. and Marco Pl. Fregoso states that Park's office is already having discussion with DWP. No solutions yet, looking at options.

Darcy Stamler – we seem to have time. Keep them on park strip? In some places, they might be damaged. Let's find a way to keep them where they are.

Louise Mingenbach – sad if they leave the neighborhood, horrible if they were in one spot

Udhav Detha – this is a brainstorming exercise for engineers and architects. Can we add more people to come.

Vanek motions to bring proposal to board Mack seconds.
