Vanek read EACC mission statement from committee page, agreed to maintain it.

7.2 [ADMINISTRATIVE] Ideas and goals

Hill –Looking for clarity and avenues to support schools and NPOs, do events, help students and community.

Samiley mentions some NPGs that were rewarded in the past through EACC.

Vanek discusses tour guide map for art and culture in Mar Vista.

Samiley talks about a cultural event during two-year term such as street fair. Encourage youth engagement events. Collaborating with Outreach committee. Stated that some stakeholders criticize MVCC for not doing enough community-building events.

Kadota – Would love to bring back a fall festival at Mar Vista park with community leaders. Mar Vista Music Project (fiscally sponsored by Transformation Arts) to encourage local musicians, roughly 15 artists. Launching PorchFest LA, a national event: a week of free concerts on people's front porches or backyards. Intend to bring PorchfestLA to greater Mar Vista, bring live music to WestLA. Greenwise garden tours in the past. Maybe a "Taste of Mar Vista" event—row of craft artists, restaurants, music, etc. Centennial of Pacific division of LAPD this year. Have a cultural guide for each month. Create a "Welcome to Mar Vista" guide, with all area civic services listed and how to get things done, list of important contacts, etc. Do a craft fair for artists and makers. Mar Vista Music wants to create a youth-oriented recital event for students to perform to public.

Hill talks about San Gabriel has a cultural talent show for their local talent; "Mar Vista Youth Got Talent".

Samiley suggests a "Trunk or Treat" event, cars in parking lot with treats for kids.

Kadota – do a dance event once a month, a different styles of dance.

This MV gateway mural is a joint project of CD11, CD5, Federal Dept of Transportation, etc. Local stakeholders generated ideas and presented to artists vetted by DCA. There is a panel of local stakeholders to select the final artist.
