DIRECTOR'S MOTION (FUNDING MOTION - NEIGHBORHOOD PURPOSES GRANT)

TITLE: Neighborhood Purposes Grant for Community Disaster Preparedness Foundation – Westside Village CERT Neighborhood Staging Area Kit

BACKGROUND:

This motion proposes a Neighborhood Purposes Grant (NPG) to the Community Disaster Preparedness Foundation, the 501(c)(3) representing Westside Village CERT. The Community Emergency Response Team (CERT) program is a vital, all-risk, all-hazard training initiative managed by the Los Angeles Fire Department (LAFD). CERT volunteers are trained in basic disaster response skills such as fire safety, light search and rescue, and disaster medical operations to help protect themselves, their families, and their neighbors in an emergency. The applicant seeks funding to acquire and install a CERT Neighborhood Staging Area Kit at St. John's Episcopal Church in Westside Village.

The purpose of this project is to establish a centralized resource that enhances local disaster preparedness and response capabilities. In addition to serving as a resource during an emergency, the kit will be instrumental in supporting CERT-led preparedness trainings. These trainings will be free and open to the entire Mar Vista community, providing all residents with the opportunity to learn practical response skills.

The total NPG amount requested is \$4,000.00, detailed as follows:

- \$3,000.00 for the hard costs of a secure outdoor storage box and disaster-response supplies, as itemized in the attached budget.
- \$1,000.00 for the costs associated with installing the kit in a publicly accessible location.

Should the initial purchase and installation costs be less than the budgeted amount, any remaining funds will be used to procure additional supplies for the kit.

Approval of this grant is contingent upon the applicant submitting the required documentation. The NPG application has been submitted but is pending the final signatures from the officers of the Community Disaster Preparedness Foundation and the attachment of their IRS 501(c)(3) determination letter. The release of funds will only occur after these documents have been received and verified.
