# 4. WELCOME. ANNOUNCEMENTS and COMMUNITY MEMORIALS

Deborah: Porchfest LA is coming 11/1 and 11/2 next weekend. We have 20 hosts who have donated their front porches for performers. These are free events and there are maps showing where to go.

Carolyn: The map is on our website.

# 5. ELECTED REPRESENTATIVE, GOVERNMENT AGENCY AND CITY DEPARTMENT REPORTS

Matt Halden CD11: Update on homelessness. There is an encampment on Venice and McLaughlin as well as issues at the Mar Vista rec center. We targeted the bike chop shop at Venice and McLaughlin. There was a lot of cleanup that happened. Individuals must be amenable to accepting services. If you have concerns about SB79 connect with me and I can reach out to our planning team. SB79 supersedes all city planning projects we currently have. It is out of our hands at this point. We will just have to navigate this as we go forward. Beethoven Market has been given a third order to comply. This will trigger the revocation process. They have been referred for a criminal filing as well. We have been calling the neighbors to let them know the updates. We have two Dodgers watch parties at the rec center 5-9.

Katie Abrams with Supervisor Horvath: Board approved a proclamation of local emergency last week. This will allow the county to mobilize resources. We have know your rights cards if you need them. We also launched the emergency rent relief program to help people destabilized by wildfires and immigration enforcement. The County's small business resiliency fund is open for applications until the end of the month.

Kenneth Calderon with Assemblymember Isaac Bryan: Assemblymember Bryan had 13 bills pass out of the legislature. Of these, 12 were signed into law by Governor Newsom. The bills covered issues like foster youth support, higher wages for incarcerated firefighters during wildfires, eviction protections for senior tenants if their social security payment is interrupted, and increased police transparency for in custody deaths and police misconduct. Our office is in the process of planning our annual holiday events – our Thanksgiving and Christmas drives. Please stay tuned as we finalize the details of the events and share flyers soon!

Charlene: We have a new NEA advocate. She will be at the meeting next month.

Janet Turner from Congressman Ted Lieu: Congressman is quite annoyed that he is going to work but the speaker will not call any votes. He has written a letter to the speaker asking him to come back and negotiate, but no response. He wrote another letter to the department of energy about clean energy project terminations. He is also pushing to extend telehealth accessibility. State and local authority over pesticides is limited now. He had a round table on the affordable care act the other day. Rates are going to start increasing November 1. If you have an issue with any federal agency please reach out.

Stakeholder: Beethoven market is still an issue. The intersection of Beethoven and Palms continues to be a very dangerous situation. We need your continued support to put pressure on the City to hold this owner accountable.

Kalani: I wear LED lights to make sure that drivers can see me when I walk. Tonight when I was making a right turn onto Palms, a guy was crossing the street wearing black and unlit. Do not rely on the government to create bike lanes but focus on personal responsibility.

Dorothy: I've worked at the YMCA for years doing the minutes. Thank you Dr. Rafeedie and Jakob for doing all the minutes.

Stakeholder: There is a dangerous intersection where the stop sign is obscured by trees at Palms and Stewart. Matt and 311 have not done anything about it, they just need to trim the tree.

[Policy] [TI&S] Left-turn Signal Installation at the Intersection of Centinela Ave. and Ocean Park Blvd. - Discussion and possible action regarding a motion that the MVCC communicate with LADOT and Councilwoman Traci Park about supporting a traffic study regarding the installation of left turn signals at the intersection of Centinela Ave. and Ocean Park Blvd. going every direction, to prevent unprotected left turns and illegal u-turns that have caused many car accidents.

Jakob: A stakeholder brought to our attention a traffic danger issue at this intersection. The lack of a protected left turn lane headed north or south has led to numerous accidents and with traffic backlog at rush hour encourages drivers to make illegal left and right turns. We would like to ask the city to do a study about adding signals.

Greg: This isn't Bundy right? No.

Carolyn: Is that where the business park and homes are? Yes.

Jennifer: Do we ask for a study or for that? April: This is the first step of what we need to ask for. We don't necessarily understand the traffic patterns enough to say that's what we want.

Aaron: Jurisdiction? Jakob: This is within our jurisdiction.

Delaram: If it is not in our jurisdiction, we still have the right to request it right? Charlene: We couldn't as a group vote on this if it involved Santa Monica.

13.6. [Policy] [TI&S] Sidewalk Installation on National PI. - Discussion and possible action regarding a motion for the MVCC to communicate to the LA Department of Public Works and Councilwoman Yaroslavsky that it supports the installation of a contiguous sidewalk on National Place between Overland Ave. and Westwood Blvd.

April Peterson: This would encourage the addition of sidewalks to National Place across from the Trader Joes. On both sides of the street there is some sidewalk, but it is not contiguous. People use this street to get to Trader Joes from Palms and a lot of people are walking in the bike lane. This is a short section and it would just take a little bit of sidewalk addition to make a complete walkway.

Jakob: We recognize that there are some difficulties here with private property.

# **Public Comment**

Spencer: This is a major thoroughfare. Without a sidewalk there is no path for pedestrians, so we need one.

Kalani: I don't support this motion. People don't walk sidewalks here because they don't want people walking through this neighborhood.

Tommy: With the condition of the sidewalks in Mar Vista I oppose adding any more sidewalks.

Megan: I use this trader joes and the parking lot is terrible so a lot of other people park along Westwood which adds more pedestrian traffic.

#### **Board Comment**

Ian: I represent Zone 1 which is part of Westside village and we are proudly in the MVCC. I run on this road a lot and use this Trader Joes. It is a horrible road to run on, it is good to look at this and at least see if it is possible.

Aaron: I used to teach at Adat Shalom. It gets very busy in that parking lot. A lot of people park along Westwood and then you are opening your door into traffic and there is a hill. This is an extremely dangerous street.

Carolyn: I would not want the City to come to my house and tell me a sidewalk has to go there.

Charlene: I'm very familiar with this street, my kids used to go to daycare there. Because it's a major street with no sidewalks it is very dangerous. I think this particular street should have sidewalks for safety reasons.

Andrew: There must be some city liability here with not having a sidewalk. It would be cheaper to try and come up with a solution to provide a safe pedestrian passage rather than having someone get hit.

13.7. [Policy] [DIRECTOR] Request to Strengthen Protections Against Unlawful Immigration Enforcement in Los Angeles - Discussion and possible action regarding concern of inadequate enforcement of the City of Los Angeles's sanctuary policy, including Ordinance No. 188441, in the face of overreach by the Department of Homeland Security (DHS) and Immigration and Customs Enforcement (ICE).

Jakob: I have been very disturbed by the immigration enforcement actions in our community. As discussed in the motion, the government is using racial profiling to arrest people on suspicion of immigration status violations, leading to the arrest of noncitizens and citizens alike. As a neighborhood council we should be invested in protecting all members of our community, and should encourage the City to take as decisive action as possible to combat this overreach.

# **Clarifying questions:**

Andrew: My understanding is that the ordinance is being questioned federally, is it legal? The motion itself and what's in the letter are disconnected, you are asking for more than what the ordinance requires? There is so much here and it is such an overreach that I am uncomfortable with going along with it. Jakob: The ordinance is currently challenged and this is asking for more than the ordinance.

Carolyn: The city has said that we are going against what ICE is doing? Yes.

Deborah: What are we voting on? Jakob: Sending this letter.

# Jakob/Delaram move to approve

Spencer: I think it is a moral imperative that we do everything in our power to prevent people from being detained for their race or language. This would be helpful in getting the City to protect the people of Los Angeles from getting detained for racial reasons.

Kalani: I agree with Andrew. This is too broad. It would be easier to say that the MVCC supports LA doing everything they can to fight against ICE. I am against the designation of sanctuary cities. Many people here are migrating legally.

Tommy: I think we can all agree that what the federal government is doing is critical. But this is a rant, not a motion. Kudos to Jakob for giving it a shot.

Stakeholder: Thank you for raising the voices of our neighbors in our community. I am in support of this letter.

#### **Board Comment**

Delaram: I hear and agree with people that the ask is going above and beyond. But I think that going above and beyond is necessary to match the actions of the federal government. I support this motion because when the City council voted for this sanctuary city ordinance, they were on record with supporting people.

Many people who voted for that policy are not now speaking up on behalf of immigrants.

Jennifer: I like the intent of the letter but I think it is too far reaching. On July 11 Mayor Bass did instruct every city department to develop and implement plans for the things in the letter. I would like a more narrow statement about how we care about the needs of our residents. I would like to see this reconstructed to a shorter statement.

Andrew: It is not the concept that's the issue, it's the execution. I would never want to put my name to this without double checking everything and fact checking. This reads like something from DSA.

April: I understand a lot of the concepts behind it, but at the same time, I feel like this is too much.

Greg: I agree with the intent but that this is too much.

Kalani: I support tabling, but tabling is normally used to kill a motion. It probably should go to committee.

Tommy: We could always form an anti-ICE committee.

Deborah: I have a problem with director's motions, I don't think anyone had enough time to go to your zones to get a feel on this. It would be nice if it went to committee, such as an ad hoc committee. I really just hear personal opinions.

# **Board Comment**

Aaron: I want to thank Jakob for bringing this. I was at the Venice NC meeting and stakeholders were asking why aren't we doing something about this? Things are changing so fast that we need to do something quickly. Jakob: Should we just cut the background information.

Jennifer: Since the mayor already did something in July, it could just be an accountability on that.

Jakob: I am against tabling because I am upset and this is how we should feel. I'm not bothered by the background section of the motion feeling like a "rant" because we are a mouthpiece for our community and from discussions with stakeholders this is how the community feels about this issue.

Jennifer: There are many things here that make it so complex. We don't know enough about how these things are operating to make these demands. I don't want to assume what has happened or not happened under the mayor's order. I know people who are undocumented that have all kinds of resources. I don't want to make complicated requests and that's why I don't want to put my name on it at this point.

Carolyn: I'm getting a vibe here that there might be some judgment on whether we are going to vote yes or no on this. I don't want people to judge me if I vote no on this. I have two sons who are half Hispanic and have them carry their birth certificates. We have another duty to be presentable to the city council.

Deborah: I appreciate what you just said Carolyn and I appreciate the letter. If we were voting on sending the letter I would vote to send it.

Kalani: Once again DTLA caved to the special interests. Like Tommy, I wasn't raised with AC and I survived. I survived serial killers also. I don't know why they didn't allow tenants to put in AC units at cost. We are coddling everyone, bike lanes, AC, etc.

Andrew: I support this, the council file is misguided and this is a nice protection for small landlords.

Aaron: I support this too, the council file addresses climate change as the issue here, and it is true that the heat is a big problem for people.

13.9. [Policy] [PLUM] Support for CF 25-0247 – Single-Stairway at Multifamily Buildings –
Discussion and possible action to support Council File #25-0247 allowing Single Stair buildings across the city to decrease the cost and increase housing supply in Southern California.

lan: This would direct building code updates allowing for single stair buildings across the city. There would be limits on floorplan size and there are considerations for fire safety. This would allow for lower construction costs in a lot of projects. This motion supports the council file and directs the committee to convene an advisory panel.

# Clarifying questions

April: Is this a study or dictating a certain policy? Ian: This is a study. April: Would these buildings be required to have elevators? Ian: No elevators required.

Carolyn: Does it make sense to have one stairwell? Ian: There are LAFD requirements to ensure safety.

Delaram: Is the current requirement 2 stairwells? Ian: Yes.

Greg: Is there any handicap consideration: Ian: ADA and Fair Housing Act apply the same as normal.

Carolyn: Why have this? Ian: It creates more flexibility allowing for larger apartments or other airflow. Some people who have studied this have determined that airflow is better during a fire.

Aaron: Have you seen any opposition? Ian: No one at the Plum committee.

# Greg/lan move to approve

#### **Public Comment**

Kalani: I oppose this. I don't know how many of you remember the 1911 Triangle Shirtways fire. People died because they didn't have proper exits. Our kids are obese and our population is fatter. One fat person will block a stairwell. Try getting down stairs in an emergency.

Tommy: Up to six stories they would allow just one stairwell?

April: There would be a maximum of four units per floor for safety reasons.

Stakeholder: Is this only for new buildings? Because we recently added a roof deck and had to add two stairwells.

#### **Board comment**

Greg: People don't just leave during a fire, it's chaotic.

Jennifer/Charlene move to extend 5 minutes, no objection

Aaron: Many firefighters object to this. They are arguing that this will reduce the cost of building an apartment, but the firefighters are concerned that they are trading the reduction in costs for safety.

lan: The safety requirements are built in to the motion, these apartments would be safer than two staircase apartments. Allowing for cheaper building is important to increase housing supply.

Jakob: Ian informed that there are specific fire safety standards for these buildings above and beyond the normal.

Aaron: West Los Angeles NC supported this.

Charlene: This is what I used to do. There is heavy code involvement here. There is something to be said for trying to get more housing. This motion is safe because it asks for expert help.
