- Community Improvements

NPG-funded projects and activities must be for a **public benefit** and purpose, **open**, **accessible**, and **free of charge** to stakeholders.

Grants approved by NCs exceeding \$5,000 involve further review and possible City contract by the Office of the City Clerk.

MORE TOURISTS VISIT THE DYNAMIC CONFINES OF OUR COMMUNITY THAN ANYWHERE ELSE IN THE WESTERN REGION OF THE USA. THIS IS LARGELY DUE TO ONE OF THE WORLD'S BUSIEST AIRPORTS, LAX, AND TO VENICE BEACH. THE PACIFIC COMMUNITY IS 25.74 SQUARE MILES IN SIZE, HAS OVER 200,000 RESIDENTS AND IS UNDER THE JURISDICTION OF OPERATIONS-WEST BUREAU.
