7.1 [ADMINISTRATIVE] Proposal for Mar Vista Neighborhood Flag (see supporting documents)

Leo presents idea for flag (supporting document)

Poppink: did you come up with this idea?

Leo: Interested in politics and flag. He came up with design. He hopes to see it in MV schools, and maybe city council.

Stephanie: One flag?

Leo: Three options, but the first is the main one.

Vanek: Explained best option might be to ask for a flag proposal first, and then propose the designs as part of a community effort.

Poppink: this could be bigger to go across the whole city

Leo: Likes idea of holding school contests across the city.

Vanek: Motions to support Leonardo Longo's neighborhood flag proposal project at the MVCC board meeting and encourages him to present there.

7.2 [FUNDING] NPG for Clover Elementary (see supporting documents)

Gaby Doyle – Grantwriter for Clover Ave Booster Club and Stephanie Lindsay, Treasurer of Clover Booster Club present NPG (see supporting documents)

Clover Elementary is:

A three Time Blue Ribbon ward recipient. Regular neighborhood school, not a charter.

498 students, TK-5<sup>th</sup>, very diverse, many international families

School funding is very basic—just average daily attendance (ADA), not title I funding

Asking funding for 2026-2027 school year for Modern Band program. Budget is trying to keep personnel.

Booster club is source of funding, paid \$72,000 to keep school aides. Booster funds PE and art program, computer lab.

Modern Band program – music is a right, not a privilege. Arts programs help all curriculums.

Request: Start a modern band, built on success of ukulele program. Looking to add keyboards, bass, drums, guitars. Looking for equity and access to ensure all students have access to instruments.

Culturally relevant- students learning music from their home culture, and connect to other forms of music. Band fosters life skills, creativity, teamwork, etc. Music programs improve attendance and helps social-emotional learning. Provides buy-in to continue further education.

Community impact: wants students to go out and perform in community

Current request: \$1336 for zip kits.

Poppink: Asked about zip kits being drums, and how many they can get with the requested money. And storage locker?

Gaby & Stephanie: would be rotating instruments. There was theft before, and there is a need to secure instruments.

Poppink: Would the grant be itemized?

Blue: It would help.

Vanek mentions there is a moratorium on funding of at least a year. Is it worth it to ask for \$1336 now, or wait until next fiscal year and ask for a higher amount?

Gaby & Stephanie: considering coming in next fiscal year.

Director Blue can bring up the NPG as a director's motion if needed.

Noted: Clover Elementary received MVCC funding for arts program before.

NPG withdrawn by Clover Elementary for now.

Leo remembers his music teacher say funding was really low, and this could be a good way for more music funding in schools.

Director Blue departs at 7:43.

Vanek explains he has not had time to work on mural tour map. Still hoping to get comments, wants to make an electronic version as well as a print version so text is not limited by paper size.
