Charlene: I wanted to announce to the Board that midterm elections for executive officers will be held at the next meeting, so if you would like to nominate people for positions, please be prepared to do so. At last month's meeting, we had a large showing for Beethoven Market and had a packed house. I have been in communication with our contact here at the school to see if we can have a larger space when we have larger meetings from certain agenda items. I have heard concerns and complaints about last month's meeting.

Carolyn: We are going to be at Venice Fest on Saturday. We are also going to table in July at the Farmer's Market. We got our banners put up on Sawtelle! They will be up for a year.

4.1 **Santa Monica Airport Conversion Project (SMACP) Presentation:** Amber Richane, Principal Design & Planning Manager, City of Santa Monica – Special Projects

Amber: I am the principal design and planning manager with the City of Santa Monica. We are the team leading the airport conversion project which is in Santa Monica but borders Mar Vista on one side. The airport is at the southeast corner and is 4% of the land area of Santa Monica. We are allowed to close the airport at the end of 2028. In 2014, a local ballot measure passed by 60% only allowing the City to build new parks, public open spaces, or recreation facilities on Airport land. In 2017 we entered into a consent decree with the federal government allowing us to close it. We are required to let them be an airport until the end of 2028. Some acres are in Los Angeles, in Mar Vista, but the City of Santa

Monica owns all of the land. This is a regional asset. The whole west side of Los Angeles will benefit. The County of LA did a park needs assessment in 2016 and this area is in great need. We have been working with the community starting in 2024 listening to what people will want. We are at the step of defining a framework diagram. This is our 102nd public meeting and have had community meetings where 800 people have shown up. We are really trying to get information out there. Visit the website for guiding principles and more information. Passive recreation was the highest priority for people of the 94 uses put forward. This is the first time that we are taking the program and showing where things might go. We are thinking about how to bring people into the park and connect different parts of the park. There is deep history with this airport that we don't want to lose. The parking is currently very concentrated, and we would want to spread it around. We are focusing on providing places for people to connect with nature as SM builds more multifamily housing without backyards. We are also going to be sure and include active sports facilities. We want to keep all of the buildings there and enhance them. See website for framework diagram. On day one, we are going to focus on getting back this area to the public. You might be able to bike on the runway! We have gotten broad support for the framework diagram, the next phase is for planning with funding and phasing. Thefutureofsmo@santamonica.gov

Frankie: Where Dewey and Stewart come together, will that be open to cars? A: There will only be a bike and PED connection, no cars.

Kelani: I have spent a lot of time around this park. SM is known for having a large homeless problem in their parks. There is a lot of concern that this park will attract homeless. There is a group trying to stop this project out of fear trying to stop the homeless and developers also want to develop this land which would cause horrible traffic congestion for this area. This airport helped win WWII. This airport has been here forever. Is there any way that this runway could remain and have the business complex turned into residential. There are a lot of parks in this area, and Griffith Park is huge. I would rather see a mixed use and keep the airport. I am an aviation and history buff but also pragmatic. A: This project is different because there is already a fence that goes along the whole thing. We have the ability to open and close this park because of that barrier. The ability to have gates and locks and times when people are not supposed to be there makes it easier to enforce. We are working to not exacerbate a problem. Measure LC is a charter amendment, so it would need to go back to the vote of the people in order to allow for further housing. Our council in January of last year told us to study some housing, but that effort has passed. Additionally, there is a relationship between park as primary use and other uses that support it as ancillary uses. We believe that we will be able to program in some modicum of supporting vendors in the area.

Derl: I am very excited for this. Are there any connections with BBB and metro about how this will connect to the Eline?

A: Ocean Park already has the 8 line running to UCLA which passes by the Eline. We are trying to open everything up to bike and PED. Metro is looking at the alignment for the Sepulveda pass project and how to connect it. We are within a mile of the Bundy station, if we can start to make Bundy easier to walk on that would be great. We would want to create a park entrance at National from West LA. This would also be a potential transit hub.

Andrew: It seems like nature and immersive is on the Western side but Active sports are on the Eastern side, which is less desirable. Is there anything that could be done at the Eastern side that is more park-like? A: These sports fields will be grass, and how these edges are treated are very important to us. There will be walking paths going through this area. The eastern part will have some of the best views of the Ocean and the Santa Monica mountains.

Carolyn: How much parking will actually be here by Bundy? There will still be people driving and during events in this area people are parking in our neighborhood which sucks. A: Parking is absolutely part of this project as much as we want to emphasize biking and pedestrians. We will have a lot more control of this once the airport closes.

April: Are you going to have dog spaces? A: Yes, absolutely.

Stephen: For the area that is in Mar Vista, how is that area being addressed? It is owned by SM but is in the City of LA. Is there any kind of communication? A: The Westside community plan is working its way through the group. It is zoned for single family housing, as long as it remains municipal use they will allow it to remain that way.

Stakeholder: 23rd and Bundy get high traffic. Is there any considerations towards how the increased traffic ends up getting relieved around Walgrove? A: We will go through a whole CEQA process and evaluate those things.

April: Is there a plan to mitigate people parking and walking in? A: Yes, we are considering that. These areas do not have preferential parking yet.

5. ELECTED REPRESENTATIVE, GOVERNMENT AGENCY AND CITY DEPARTMENT REPORTS

Matt Halden CD11: I have been receiving emails from members of the community involving one off RV dwellings. If someone is living in their vehicle it makes enforcement harder because the city has to go through a specific process to compel the vehicle to move along. It is important that we are aware of where vehicle dwellers are. We are continuing with weekly operations to address encampment issues at Mar Vista park. Encampments are technically illegal at parks, but when enforcing officers are not on site it is difficult to patrol those areas. We are trying to build better rapport with the individuals involved. Saturday is Venice Fest from 12-8 along Venice Blvd. between Centinela and Inglewood. On Sunday we have our Venice Beach takeover for Paul Rodriguez day from 12-8.

Janet Turner for Ted Lieu: The congressman has created a social media project running on July 4. It is called America 250 veterans' commemoration. We are asking you to send a photo and small tribute of a veteran loved one. The congressman today introduced the return of world refugee day. Introduced another bill called keeping pets and families together.

Paige for Lindsey Horvath: She established our first ever ethics commission, a milestone advancing the mandate approved by voters back in 2024. This will direct the county departments to identify existing ethics related funding and positions. It will also direct the establishment of a budget for the ethics commission. This should restore trust and accountability in the county. We are hosting a world cup watch party on Friday June 26. Congratulations Leo and Chloe for being involved at such a young age.

Erika for DONE: Chloe joined the department at City Hall for the Empower LA youth conference and served as a panelist and shared her insight. She did a great job of saying why it's important to be involved in your local community. Budget day is coming up in 2 weeks on next Saturday at City Hall from 7:30AM to 12:30PM. There are also NC excellence awards coming up. The City Clerk's office requires that the NC do an inventory check every 2 years.

13.4. [Administrative] [Town Hall Planning AD HOC] Selection of Venue and Date for MVCC's 2026 Town Hall in October – Discussion and possible action regarding the MVCC selecting a

date in the month of October to host its 2026 Town Hall, and also to select the venue (Mar Vista Branch Library or Windward School).

Aaron: The ad hoc committee has been meeting and we would like to book a venue. The two options are Windward and the Mar Vista Library. The library has a capacity of 60 and it can be opened specifically for us for a fee. We can cater or serve snacks for extra money. If we go with the library during Saturday and serve no snacks it costs nothing. Sunday includes an extra \$216 security fee in order to use the library when it should be closed. Windward would provide a space only on Saturday and could seat 140-230. There would also be breakout rooms available. There are screens and connections available. The total cost would be \$1,332.

Clarifying questions

April: What are we planning on presenting at the town hall? A: There would be a general presentation and then there would be breakout groups for the various committees. The idea is that we are meeting with the community and they are meeting with each other.

Carolyn: What do you think we need to do to get people to come to this versus a meeting? A: Marketing this is an outreach task. I don't know how many people we would get. At the farmer's market, our meetings, and the newsletter would allow people to RSVP.

Greg: We had a meeting on Grand View a year or two ago which was pretty well attended.

Carolyn: Say we book the library and start marketing the event, how many people do we need to RSVP in order to have the event. A: We have to predict what we are going to need.

Jennifer: I don't want to be a naysayer and I like this idea. What brings people here is controversial issues, I once participated in something like this that a realtor put together and there were 20 people. I wonder if it would be possible to carve out some of the time we already meet to do meet and greet time. Can we have a townhall at the meeting? A: My hope is that there is a lot of people who aren't aware we are here or what we do and how to do it. It was floated in the committee meeting that we have someone show up. This is important to introduce us the council specifically.

[Policy] [TI&S] Request for LADOT to Evaluate 1) Speed Limit between Walgrove Ave. & Sawtelle Blvd. on Palms Blvd., and 2) Street Light Timing at the Intersection of Palms Blvd. & Beethoven St.** – Discussion and possible action regarding the MVCC asking LADOT to evaluate the speed limit between Walgrove Ave. and Sawtelle Blvd. on Palms Blvd., and also the street light timing at the intersection of Palms Blvd. & Beethoven St. given the current traffic flow and increased density.

April: This would be a motion to have LADOT evaluate the items mentioned in the motion. There is a difference in the speed limits along different sections. A community member brought it up and was concerned about the speed limit and the timing of the light. After discussion, it was voted on to bring it to the board and have LADOT evaluate it.

Clarifying questions

Ian: The most dangerous portion of Palms is from Sawtelle to Overland. Would you consider amending this to include all of Palms to Overland.

Aaron: Should we direct this to Councilmembers as well? A: Sure.
