Re: Council File 11-1531-S3, Plastic bag charge

At its regular meeting, August 14, 2012, the Mar Vista Community Council approved the following policy motion:

The Mar Vista Community Council, representing 55,000 stakeholders in Los Angeles, strongly opposes the above-referenced motion introduced by Councilmember Parks on the grounds that the motion is based upon questionable studies sponsored by the plastics industry and, that, by attempting to direct the 10 cent charge on paper bags, the City would be exposed to costly litigation.

Reusable grocery bags have been used for decades in the United States and elsewhere without reported health impacts. In the 49 jurisdictions in California alone that have adopted similar ordinances encouraging the use of reusable bags, there have been, again, no reported health impacts. Consumers walk into grocery stores every day without washing their hands, pick up food items and place them on the same counters and conveyor belts. Also, studies have shown that cashiers are exposed to bacteria from handling money.

The appropriate hygienic use of reusable bags is a matter of basic good hygiene practices as outlined by the CDC in their outreach and it is worth noting that nowhere does the CDC cite reusable bags as a risk factor

In addition, attempts to direct the 10 cent charge on paper bags could expose the City to costly litigation.
