Re: Santa Monica Airport

Dear Councilmembers:

As immediate neighbors of the Santa Monica Airport, Mar Vista residents are impacted daily by the nuisances and serious health hazards created by the airport: air pollution; noise pollution; safety risks, among others. For this reason, years ago the Mar Vista Community Council ("MVCC") formed a committee to address the concerns of its residents and to monitor activities at and about the airport.

At the regular October monthly meeting of the Mar Vista Community Council Board of Directors, the following Policy Motion was presented and passed, with approval to forward same to your attention.

WHEREAS the Santa Monica Airport Commission (SMAC) has approved and forwarded to the Santa Monica City Council SMAC Recommendations 2012-02, 2012-03, and 2012-04.

WHEREAS Santa Monica, Mar Vista, Venice and other immediate neighbors of the Santa Monica Airport are impacted daily by nuisances and serious health hazards created by airport operations: air pollution; noise pollution; safety risks, among others.

WHEREAS SMAC Recommendations 2012-02, 2012-03, and 2012-04 propose solutions worthy of consideration and adoption to mitigate the nuisances and serious health hazards created by airport operations.

WHEREAS SMAC Recommendations 2012-02, 2012-03, and 2012-04 reflect the opinions and desires of the majority of people who participated in the Santa Monica Airport Visioning Process.

BE IT RESOLVED that the Mar Vista Community Council supports SMAC Recommendations 2012-02, 2012-03, and 2012-04 and urges the Santa Monica City Council to support and proceed with Recommendations 2012-02, 2012-03, and 2012-04.
