Report by Co-Chair Martin Rubin - On March 11th, the 9th Circuit Court of Appeals in Pasadena will hear opening arguments for the lawsuit filed by the City of Santa Monica against FAA regarding title to the property known as the Santa Monica Airport. The lawsuit asks for relief from the claim by FAA that the City must operate the Santa Monica Airport in perpetuity.

The City of Santa Monica served an Unlawful Detainer to Justice Aviation. Also, Gunnell aviation may not renew their lease. The two are aviation businesses at SMO. On February 24, 2016, the North Westdale Neighborhood Association (NWN) will have as their guest, speaker Nelson Hernandez, the new Senior Advisor to the SM City Manager on Santa Monica Airport Issues, and at the NWN April 8, 2016 meeting Congresswoman Karen Bass will be the guest.
