I. Update on Board motions

A. Beach Curfew motion; passed at 8/31/18 Special BoD meeting

Passed at MVCC BoD and conveyed to WRAC where we tipped the super majority; a letter from WRAC has been written.

The issue was not approved at POSy but was at PLUM and the BoD. At the least it is supportive of our neighboring NCs. And the issue has forced more careful negotiation between CoLA and the CACC, which still has not agendized the issue for public consideration.

B. Tree Removal process; passed at 9/11/18 BoD meeting (WRAC motion but letter should be composed, CIS?)

Passed at BoD and considered at WRAC. CD5 deputy has been closely involved with UFD (Urban Forestry Division) renaissance and believes delimiting a 45-day deadline is too restrictive. Better to facilitate closer communications with CDs and NCs. Better request is being addressed at this level for WRAC consideration and motion-sanctioning in October.
