Several of the original new trees and plants are dead, removed, or dying.

Rare exterior maintenance has been completed at this location since first built and this undermines the good service by the interior dedicated employees.

The MVCC urges an increased budget for exterior landscaping maintenance, trash pickup and graffiti removal at this location.
