The city's OCT Monthly Expense Report (MER) will not be ready until after the 5th of each month. Below pls find the city's accounting as of 10/31 5pm.

Budget background: The city gave each Neighborhood Council (NC) \$32,000 this year (previous year was \$42,000)

A new policy allowed NCs to encumber funds because of the covid shutdown in March. We encumbered \$3100 of our remaining balance of \$9040

- -\$2500 the balance due to The Web Corner for website upgrades
- -\$600 for the bus bench advertising

Cash Balance

All NCs can carryover up to \$10K, our carryover is \$5940.95 (notice dated 8/1). I added it to our budget total (\$41,040.95) under misc outreach.

The latest request is for the ADA compliance checklist to be completed by the park and if more info is needed later regarding that DONE (Freddy) will be asked to complete/gather the rest of the info.) We may also need to use some of the carryover if we can't get rid of the excess in the storage unit or store everything at the park. Please note this venture started with just storing our meeting equipment at the park rather than hauling it back and forth to a storage unit with the hopes of at least downsizing. Budget reflects 6 months of rental, so come Dec we may need to add some funds to this category.
- -City is still working on a contract with the web corner (for the balance \$2500 of upgrades and the monthly maintenance, city originally had a contract with TWC but that ended 6/30/2020.
- -Still waiting on the bus bench contract (per Kathryn)
- -Possible NPG request from safety committee.
