- 6. Policy Motion: Proliferation of Recreational Vehicles in Mar Vista (submitted by Transportation & Infrastructure Committee)
- WHEREAS, It has been noted that there is an increase in long-term Recreational Vehicle proliferation throughout Mar Vista, on both major commercial thoroughfares and residential streets, and
- WHEREAS, there is some confusion as to where updated LADOT maps allow for Recreational Vehicle parking, and what the roles and responsibilities for the LADOT and LAPD are to enforce laws related to Recreational Vehicle locations,
- THEREFORE, the Mar Vista Community Council strongly encourages Council office 11 and Council office 5 and other LA city agencies to enforce LAMC Ordinance 85.02 and correct the map.
- THEREFORE, the Mar Vista Community Council supports the work of Councilmember Mike Bonin to increase the amount of parking made available to vehicle dwellers with the Safe Park program in private parking lots including those of faith-based organizations.

- THEREFORE, the Mar Vista Community Council asks Councilmember Mike Bonin's office to explore expanding the Safe Park program to include city owned parking lots that are currently empty in the evening.
