The mission statement reads as follows: The MVCC Committee on Public Health and Safety is committed to building a more resilient Los Angeles for all residents of Mar Vista, especially children, seniors, immigrants, and lower income residents. Our proposed actions are about building resilience for both the impacts of unexpected catastrophic events and chronic underlying stresses.

- vi. Coffee with a Cop by Zones \$600 still available. Starbucks (corner of Venice and Centinela) will pay for the next Coffee with a Cop on Tuesday, April 30, 9-11am. That means we still have \$600 available for future events. Should we host one somewhere in Zone 1? Colonial Corners (Barrington and National), perhaps at Whole Foods? Senior Lead Officers in Mar Vista include Javier Ramirez (Zone 6 south of Venice), Adrian Acosta (north of Venice), Hector Aceves (Zone 5), Juan Ceja (Zone 1).
- c. Development of Neighborhood Watch/Block Captain Materials and Program
 - i. We need to review and revise the following materials in order to develop resources that are specific to Mar Vista:
 - 1. National Neighborhood Watch Manual.
 - 2. Neighbors United for Safer Communities produced by Tony Cardenas of Council District 6. This pamphlet is more user friendly than the National Manual. Rob's goal is to give every block captain a binder with explanations of important procedures, online resources, LAPD programs, and ways in which dog walkers can be important neighborhood watch participants. Rob and Adrian can perhaps use the next Fall Festival as an opportunity to organize block captains.
 - 3. Wednesday evening, May 22, we can invite Adrian's list of block captains to a meeting as well as other identified community leaders. This will expand the reach of the LAPD, which sends information only to block captains. In other words we can recruit block captains sooner rather than waiting for the LAPD to do so. At the meeting we can give Rob's proposed binder to each participant. (Rob will get an email list of current block captains from Adrian.) Goal: two MV block captain meetings a year and a launch in the Fall.
