# 13.8. [POLICY][AMBRIZ/HILL/INOUYE] Limited MVCC English-Proficiency Policy – Discussion and possible action regarding a limited English-proficiency policy for the Mar Vista Community Council.

#### **Background:**

In the report <u>L.A. Speaks: Language Diversity and English Proficiency by Los Angeles County Service Planning Area</u>, it is stated that:

"Los Angeles County is home to more immigrants than any other county in the nation. Nearly one in three persons countywide have Limited English Proficiency, or face some difficulty communicating in English that impacts their ability to access critical services delivered only in English. Asian and Latino residents are more likely than other residents to face language barriers; 48% of Latinos and 43% of Asians in Los Angeles County are LEP."

This report broke down US Census Data on LEP for each of the Service Planning Areas (SPAs) in Los Angeles County (attached). The MVCC in is SPA 5 (West). This information shows that:

- Spanish is the second most common language spoken in SPA 5. There are 82,905 Spanish speakers, 14.2% of the population.
- The Latino number 98,310, or 16% of the total area population. Of that group, 36,420 or 40% are considered LEP.

Among their policy recommendations:

- Develop and implement a written policy addressing how the agency will meet oral and written language needs of clients.
- Outreach to LEP communities about their right to linguistically appropriate services and how to obtain them.

More recent data from the <u>Know Your Community LA Hub</u> specifically for the Mar Vista Community Council catchment area (attached) shows that:

- Spanish is the second most common language spoken by people living in Mar Vista. There are a total of 9,592 Spanish speakers, which is 20% of the total population surveyed by the American Community Survey for their language preferences.
- Of those who speak Spanish, 1,875 or 20% are considered LEP.

Additionally, between 2017 and 2019, the <u>Advancement Project California</u>, worked to establish a Los Angeles City Office of Civic Engagement with several community partners.

On their website they state:

"In Los Angeles, significant racial and socioeconomic disparities exist in voting and other forms of public participation. Generally, Whites, individuals with higher incomes, and older individuals are overrepresented and participate at higher rates than low-income, people of color, and their younger counterparts. This is problematic because it results in policy decision-making that is uninformed by

and thus inadequately responsive to the interests and needs of all residents. The underlying factor is not apathy, but barriers, such as lower levels of income and education, **limited English proficiency**, and inaccessible participation processes. Low-income communities of color care AND want to be involved, but multiple barriers hinder their ability to participate."

Their efforts resulted in (1) the release of the report <u>Making Public Participation Equitable</u> and (2) the establishment of an Office of Community Engagement (OCE) within the Department of Neighborhood Empowerment. They state that the City is currently working on the implementation of the OCE.

#### **Motion**

The Mar Vista Community Council (MVCC) recognizes that the two most common languages spoken, written and read by our stakeholders are English and Spanish.

The MVCC acknowledges even if a stakeholder is able to speak (some) English, they may still have Limited English Proficiency (LEP) when it comes to reading and writing English.

The MVCC is aware that the issue of LEP has been cited as a reason some members of our community do not participate in our Neighborhood Council, City government or vote.

To increase civic engagement, the Mar Vista Community Council adopts the following Limited English Proficiency policy.

- 1) The MVCC will make its website accessible to all stakeholders in the language in which they are most proficient via the use of a translate button.
- 2) The MVCC will post its Board and Committee agendas and minutes in both written English and Spanish. Other languages may be available upon request.
- 3) The MVCC will provide all meeting handouts and supplemental materials in both written English and Spanish. Other languages may be available upon request.
- 4) For items 2) and 3) above, it will be the responsibility of the committee chairs/Board Secretary to obtain the translations of materials and post them on the MVCC website.
- 5) The MVCC will conduct all of its outreach in both English and Spanish. Other languages may be available upon request. It will be the responsibility of the Outreach Committee chairs to obtain the translations of the outreach materials.
- 6) The MVCC will utilize the Department of Neighborhood Empowerment and City resources available to it for translation services. The costs associated with these services will appear as a standing line item on the MVCC budget.
- 7) The MVCC will assess the language capacity of the Board by creating and maintaining a list of Board members who speak languages other than English. However, it is at the discretion of each individual Board member whether they are willing to provide translation services.
- 8) If possible, practical and/or feasible, the MVCC can recruit and utilize volunteers to help with translation services. The volunteers will be supervised by the Board. All written materials translated by volunteers will be submitted to DONE for approval before they are distributed to stakeholders.
